Dementia Program Now Prospering Nationwide

Naomi Latini, RCI REACH Program Manager, is wrapping up the training component of the RCI REACH program, which called for the national dissemination of the evidence-based program. REACH (*Resources Enhancing Alzheimer's Caregiver Health*) provides support for the caregiver through education, stress management techniques, safety tips for the patient, and skills building to help caregivers manage difficult patient behaviors.

Naomi has been extremely busy traveling since 2014, and as of today, more than 20 agencies around the country are now operating this program thanks to training from the RCI. She received positive feedback from the training sites such as the Alzheimer's Association-Florida Gulf Coast Chapter. Lisa Milne, VP of Programs, stated, "The REACH training that we received from Naomi with RCI is invaluable. The tools that we will be able to provide to the caregivers we work with will help them really take control of the way they cope with the stressors in their lives due to caregiving."

With the training portion of the program complete, Naomi has now been hired as the Training and Implementation Specialist. In this role, Naomi will continue to work with the RCI REACH program, and will also be assisting with the development of implementation training and tools for other RCI evidence based program sites such as our Operation Family Caregiver Program. The RCI is excited to see her continue to grow and nourish these sites around the country as well as locally.
