VISA CHECKLIST FOR MEDICAL TREATMENT

	Original application form, duly completed and signed. Note: For children under 18 years old, both parents must sign the application/declaration form/questionnaire. Passport copies of the father and mother have to be attached.	
	Original passport Note: The passport and the Omani resident permit (for non-Omani nationals) must be valid at least 3 months from the intended date of return from Spain. The passport must contain the signature or the fingerprint of the holder 2 free pages.	
	1 recent passport photograph Note: Passport size with white or plain light color background ; must be recent (not older than 6 months) and sized 3,5x4 cm..	
	Copy of ticket bookings or reservation including return flight with booking reference or Electronic Ticket Number	
	<ol style="list-style-type: none"> Medical report issued by the doctor in charge of the treatment in Oman or, Written confirmation of appointment with doctor in charge of treatment in Spain or, Letter by Omani government authority confirming that all expenses will be covered by them. 	
	For persons escorting the patient: confirmed hotel booking (full address of the hotel must be written in the application: full name, street name, building name & number, city and city code).	F o r
	non Omani nationals.- Letter from local sponsor, stating qualification, salary and start date of employment in Kuwait or copy of trade license if self-sponsor.	
	For non Omani nationals.- Up-to-date personal bank account statement for the last 6 months or letter of employer confirming that all expenses will be covered by employer and 1 photocopy of the insurance policy for a valid Travel and Health insurance covering the territory of the Member states of the Schengen agreement and with a minimum coverage of EUR30,000 for medical expenses or Letter by Omani government authority confirming that all expenses will be covered by them (in this case no bank statements/employer letter or Travel and Health insurance policy have to be presented)	

Please note:

The visa must be applied for either in person or through a representative All documentation must be submitted in English or Spanish language

For children registered in a parent's passport, a separate application form has to be submitted. Original documents must be presented; additional photocopies may be required

The Embassy of Spain has a right to ask any other additional documents it considers necessary, or may call the applicant for an interview. If the visa application is refused, the reason will be provided as per Schengen Immigration Rules. In all cases the visa fee and service fee is non-refundable.

Head coverings is not permitted except for religious reasons, but facial features from bottom of chin to top of forehead and both edges of applicant's face must be clearly shown.

Declaration

I have been informed that an application without a complete set of documentation according to above mentioned checklist may result to the rejection of my visa application. The Embassy of Spain reserves the right to ask for an additional supporting document and does not guarantee the issue of visa.
