Entry Deadlines:

ALL entries must be received no later than March 28 at 5:00 pm. Late entries may be accepted only at the discretion of the Tournament Director.

Entry Fees:

See first 2 pages of registration form for entry fees, which vary by event. All entries submitted online (or if mailed) postmarked after **March 15**th, **2016** must pay the standard fees. A discounted entry fee is available on the Giant Round Robin event for:

- Entries submitted before March 15, 2016 for players who live in NC
- Entries submitted before March 15, 2016 for players who provide a hotel confirmation number from the Triangle Table Tennis Tournament Host Hotel (see below).

All entries received after March 15th, and all entries received from players outside of NC that do not include host hotel confirmation codes, must pay the standard entry fees.

Host Hotel Accommodations:

The sponsoring host hotel for the Butterfly Cary Cup is the Airport Courtyard by Marriott near RDU Airport. In recognition of their sponsorship, players who register at the host hotel <u>and include a hotel confirmation number on their registration</u> may pay a reduced entry fee for the Giant RR event <u>if their registration is received no later than 3/15/2016</u>. The host hotel requests that visiting players book rooms using the booking links accessible from the Tournaments page on our web site, or call the local hotel phone number to receive the best room rates. As of the 4th quarter of 2015, they offered the following amenities and rates. Please check with hotels to confirm best available deal at time of booking.

This hotel is 2 miles from RDU Airport, 1.7 miles from Triangle Table Tennis, and provides a \$72/night special rate for Cary Cup participants. The Courtyard will provide paying guests a limited free shuttle service to and from the playing venue, airport, and nearby restaurants. (Information current as of October 2015; check with hotel at time of booking to confirm rates and included amenities.) The hotel has a code of conduct that we are contractually required contractually to share by advising our participants of the following: "The Hotel desires to provide a safe and relaxing atmosphere for our guests. To that end the Hotel requires that all guests adhere to a code of conduct that ensures that noise is kept to a reasonable level and unacceptable behavior is curtailed. The code of conduct includes, but is not limited to, excessive noise, intoxication, vulgar language, or activities that cause damage to hotel property."

GIANT Round Robin Main Event logistics:

The Butterfly Cary Cup Giant Round Robin event sells out every year, and so this year's Giant RR event is larger, with Round 1 and Round 2 spread across two separate days to accommodate the high demand from past years, and reduce the number of players who are put on the wait list. Each player registered for the Giant Round Robin will play his or her first rounds on either Friday or Saturday, depending up his/her registration. Players may register for either the Friday Giant Robin, or the Saturday Giant Round Robin, but not both, because both feed the same combined final rounds. Final rounds for the Giant Round Robin for all Friday and Saturday Divisions (A, B, C, and D Divisions) will be played on Sunday. All Friday Giant Round Robin and Saturday Giant Round Robin players should plan to be present on Sunday.

Overview for the Friday and Saturday Giant Round Robin Main Event: Round 1:

Friday: 64 players are snake seeded using geographical separation into 16 groups of 4. (Note: While 64 players are targeted, the Friday Giant RR may expand beyond 64 players, up to a maximum of 128, based on demand and at the discretion of the Tournament Director.)

- Saturday: 128 players are snake seeded using geographical separation into 32 groups of 4. (Note: the Saturday Giant RR is firmly capped at a maximum of 128 players.)
- Players are placed into one of 4 Divisions at the end of Round 1 (Division A, Division B, Division C, or Division D) as follows: at the end of Round 1, if the Round 1 group contained 4 players, the top player enters the A Division, the next player enters the B Division, the next player enters the C Division, and the last player enters the D Division.
- Exception handling: If a player in a Round 1 group is not present or ready to play, then the tournament referee can determine that player is a "No Show". Once the referee designates a player as a "No Show," then players may opt to "move up a division" if and only if those seeded above them do so, and the option is authorized by the tournament referee. Example: the Round 1 'B' seeded player is a "No Show". Then the player who was the 'C' seeded player in Round 1 may advance into the 2nd Round "B" Division if they finished 2nd in their Round 1 group of remaining players. To be clear, the 'C seeded player is not forced to do so, but may choose to do so. If and only if the 'C' seeded player chooses to move up in this situation, then the D player may also choose to (but is not required to) move up to the "C" division if he/she finished 3rd. However, if any player doesn't elect to "move up a division" in the case of a "No Show" in Round 1, then players seeded below him/her cannot do so either. This shuffling may create a minor hole or gap in one of the Round 2 Divisions, which the Tournament Director may fill from any players on the "stand-by" or wait list. The tournament referee will make the final call on all exceptions in Round 1.
- Note: TTT reserves the right to expand (or reduce) the size of the groups based upon actual entries received.

Round 2:

- Each player plays Round 2 on the afternoon of the same day on which he/she registered for and played Round 1 in the morning (either Friday or Saturday).
- In Round 2, each player plays within the Division in which they were placed after Round 1. Based on Round 1 results, players are placed into up to 4 groups within each Division; each group will consist of approximately 8 players. The players are snake seeded within the groups in their Division and geographic separation may be applied.
- Each group within each Division plays in Round Robin format. The top two (2) players on each day in each group within the B Division, C Division, and D Division advance to Round 3 on Sunday.
- The top <u>four (4) players on each day in each group within A Division</u> advance to Round 3 on Sunday.

Round 3:

- Round 3 for all Giant RR Divisions, from both Friday and Saturday, takes place on Sunday and is a single elimination format.
- Round 3 of Division A is a single elimination of up to 32 players: 8-16 from Friday, and 16 from Saturday.
- Round 3 of Division B, Division C, and Division D are single eliminations of up to 16 players: 4-8 from Friday, and 8 from Saturday.
- See entry form for prizes and start times for all Divisions.
- Single elimination matches will not be delayed for late players. Late arrival will result in default.

All Other (non-Giant Round Robin Main Event) Event formats:

All events will be conducted in round robin formats for the first two rounds, providing players with more guaranteed matches than single elimination tournaments.

- <u>USATT sanctioned Thursday and Friday events</u>: The U-1150 RR, U-1500 RR, U-1900 RR, Thursday Open RR, U-1800 RR, and 1800 & Over RR events, are all firmly capped at 32 players. For each of these events, up to 32 players are snake seeded into up to 4 groups of up to 8 players. The top finishing player in each group advances into a final round robin of 4 players to determine winners of 1st 3rd place prizes. See entry form for prizes. If fewer than 32 players enter, Triangle Table Tennis reserves the right to modify anticipated group sizes.
- Sandpaper and Hardbat events: The Sandpaper and Hardbat events are not USATT sanctioned. For each Sandpaper or Hardbat event, up to 16 players are snake seeded into up to 2 groups of up to 8 players. The top two finishing players of each group advance into a final round robin of 4 players to determine winners of 1st − 3rd place prizes. See entry form for prizes. If fewer or more than 16 players enter, Triangle Table Tennis reserves the right to modify anticipated group sizes.

Venue Schedule:

Triangle Table Tennis will extend its normal hours to accommodate the Butterfly Cary Cup check-in, warm-ups, and events. On 3/31 - 4/3, the Center will remain open until the conclusion of all events scheduled that day. On Friday and Saturday, the Center will open at 8:30 a.m. for check-in and warm-ups. On Sunday, the Center will open at 8:00 a.m. for warm-ups. Players are encouraged to check-in at least one hour before their first event begins, and may choose to check-in for the Giant Round Robin on the evening before the first round of the Giant Round Robin day on which they are registered.

General Triangle Table Tennis Tournament Information

Registration Policy:

All registrations must be properly and completely submitted. Please read the registration details carefully for each event. Your registration will be considered incomplete and will not be processed if any of the following is missing:

- ➤ A legible and fully-completed entry form
- > Completed waivers, including printed names and signatures for ALL waivers
- > Payment in full for ALL registered events, plus USATT membership or renewal fee (if needed), plus late fee (if applicable)
- A current USATT membership number or membership registration form

Full payment & fully completed entry forms are required to process an entry.

Registration Payments:

Full payment must be made at the time of registration. Accounts will be charged a \$25 fee for returned checks. Participants with declined payment will be withdrawn from the tournament.

Registration Limitations:

This tournament has a limited number of players or teams allowed for each event. Complete entries with payment are processed in the order received. Once an event is full (based on a target number set at the discretion of the Tournament Director), that event will be closed and no further entries accepted. Entering early will give you a better chance of getting into an event before it is full.

Waitlists:

If an event is full at the time you register and pay then you will be automatically put on that event's waitlist. You will be informed if you are waitlisted. You will be notified if a spot becomes available. If a spot does not become available or you request to be removed from the waitlist, the registration fees for the waitlisted event will be refunded to you.

Refund Policy:

- ALL entry fees paid are NON-REFUNDABLE after 7 days prior to tournament date.
- > Events may be cancelled for insufficient entries, or other reasons, at the discretion of the Tournament Director.
- If an event is cancelled by Triangle Table Tennis, or the Tournament Director, <u>for any reason</u>, then entry fees will be refunded. Refunds may take up to four weeks.
- ➤ Withdrawals & Refunds: Entry fees which are refundable (i.e., prior to seven days <u>before</u> the tournament), will be refunded ONLY as a Triangle Table Tennis gift card. In order to claim this, a <u>written withdrawal request</u> MUST be submitted by the player for Triangle Table Tennis to consider a refund. Please include your name, phone number, and the events you wish to be withdrawn from. All entry fees are NON-REFUNDABLE after 7 days prior to tournament date. An administrative fee of \$10 will be deducted from all refunds.

No-Show Policy:

It is the player's responsibility to manage his/her time and to be available for his/her matches at designated tables when those matches are called. Players who foresee a conflict are advised to notify the Tournament Control Desk. Players who are not present at match start time for any event are subject to forfeiture of their position and entry fees for that event.

Event Limitations:

Rating and/or gender restrictions may apply depending on the descriptions of events in each tournament. Players not present at the table for a match may be defaulted (see no-show policy). Players may **not** register for events that start at the same time or have overlapping time conflicts.

Unrated Players (players without a USATT rating):

Unrated players may enter any unrated Open event for which they are otherwise eligible, and advance in the same way as other rated players. For rating events (e.g. Under 1800, Under 1500, etc.), unrated players may be allowed to enter, but if they win an initial round, they will not be allowed to advance or be eligible for prize money or awards. In that instance, the second place finisher in the first round group (if rated) shall advance. Unrated players WILL get credit for matches won in terms of USATT rating point accrual. However, unrated players may be seeded in the draw at the sole discretion of the Tournament Director, and by the means/mechanism selected by the Tournament Director, in his sole discretion. Teams on which one player is unrated are subject to the same restrictions. By entering this tournament, players agree to and understand this provision. The Tournament Director will be the final authority on a player's rating status and qualification.

International Athletes:

All International Athletes are invited to participate in all Triangle Table Tennis Open Tournaments. Letters of Invitations will be issued upon request for athletes and their coaches; these letters will be sent to the requesting athlete. Athletes are responsible for requesting and forwarding this letter to the appropriate embassy in time to obtain any needed visa, and are responsible for their own travel arrangements and expenses. Please be advised that Triangle Table Tennis cannot assume any responsibility for contact with US embassies, coordinating international travel arrangements or providing expense reimbursement. International athletes, like all athletes, must submit completed registration forms, waivers, and payments to register. Those who do not receive a required visa in time to attend may request to have their registration payments refunded per the refund policy.

Dress Code:

Players must wear shoes with non-marking soles. Players may not wear attire that is the same color or close to the same color as the tournament ball (white or light colors). USATT Dress Code will be enforced in all cases as determined by the Tournament Referee.

Prizes:

Prizes may include cash, gift cards that can be used for Triangle Table Tennis programs or pro shop merchandise, trophies, and/or medals. All cash prizes are in the form of checks. Players must complete IRS Form W-9 and provide taxpayer ID (e.g., social security number) to receive prizes with monetary values; foreign players without a US taxpayer ID must provide a passport number.

Center Rules:

Triangle Table Tennis Center rules will be enforced; violators may be asked to leave. If ejected due to violation of Center rules, the player will be defaulted automatically and no fee refunds will be issued.

Equipment:

All USATT Regulations Apply. Only USATT/ITTF approved equipment will be used. Tables and nets will be Butterfly. Floors are all covered with Gerflor (Taraflex) flooring. Balls will be white ~40mm premium competition Butterfly poly balls.

USATT Ratings:

Ratings as posted on USATT website one week before tournament are used for USATT-rated events.

USATT Membership:

Players must have a currently active USATT membership to play in USATT sanctioned events. Players without a currently active membership at the time of registration must include their USATT registration or renewal fees, or fees for a tournament pass, along with their tournament event fees when submitting payment. Please see USATT membership page for more details on USATT membership options and rates.
