- If the quantity requested is less than that indicated quantity within the postal sector code, distribution will be provided at random without any selection.

PAYMENT

- 1) Payment must be made by cash, cheque or NETS at the time of posting.
Cheques should be crossed and made payable to "SINGAPORE POST LIMITED"
- 2) Post dated and/or personal cheques will not be accepted.

NOTES

- 1) **Minimum posting per request is \$500 and charges are subjected to prevailing GST.**
- 2) **An additional charge of \$0.08 per item (subjected to volume discount) is applicable where selective distribution is required. For example. Selection of condominium name, HDB block, building name etc**
- 3) An additional charge of \$0.20 per kg is applicable where bagging services are required. This is subject to a minimum charge of \$50 (excluding prevailing GST).
- 4) SingPost shall make all attempts to deliver the mailer to the units according to the distribution list. However, if there are feedback of non-delivery, SingPost shall conduct an investigation and if results show that 70% of the housing units that are being disputed have received the mailers, SingPost shall not be liable to compensate for the mailers that are under dispute.
- 5) Distribution classification for housing types as:
HDB units Residential units, including shop units at the ground floor.
Condo/ Pte units Private apartments, HUDC, condominiums, hostels which allow unaddressed maildrop.
Landed units Terrace, semi-detached and detached bungalows and residential houses.
Com units Commerical (shop houses, offices including residential houses at lowrise bldgs, commerical bldgs, industrial/factory/office in flatted factory bldgs)
