to make the offer in this Agreement a firm offer by removing the aforesaid contingency. If within the said 48 hour period the Buyer shall fail
to remove said contingency, this Agreement shall be null and void and any deposit shall be returned to the Buyer.

NOTICE

- A. Notice to the Buyer's attorney or to the Broker utilized by the Buyer, the Seller, the Seller's attorney or the Seller's Broker shall be considered notice to have been made on the Buyer or Seller.
- B. Personal notice on Seller or Buyer as included in this contingency shall be considered completed by giving notice to any one of the Sellers or Buyers if there are more than one Seller or Buyer.
