GENERAL INSTRUCTIONS

Please read the following qualifications for the tuition voucher for Westminster Academy. If after reading these qualifications, you believe you are eligible, please complete the attached application and return it to the Westminster Academy Business Office. You will be notified of approval status within ten business days.

QUALIFICATIONS

In order to qualify for a CRPC tuition voucher to Westminster Academy, the parent(s) and/or legal guardian must be "members in good standing" at Coral Ridge Presbyterian Church and Westminster Academy.

Members in good standing are those who have joined Coral Ridge Presbyterian Church at least six months prior to the opening day of school.

Those qualifying as members in good standing will show credible evidence of fulfilling their vows of membership, in particular vow number four, which reads: "**Do you promise to support the Church in its worship and work to the best of your ability?**" Credible evidence in this case means consistent and regular attendance at Sunday worship services, financial contributions to support the work of the church unless providentially hindered and participation in the activities and ministries of the church. In order to be fiscally responsible with the funds which have been provided and to determine that the membership qualifications are met, the following tools will be used by the voucher committee:

- 1. Attendance records—a minimum of 2/3 attendance at the church services (34 out of 52 services) The tool used to verify attendance is the Blue Connect Card located in the pew rack, check WA family
- **2. Giving** records—to determine a pattern of regular support of the church and its work
- **3. Participation** in the ministries and activities of the church, as measured by the signature of a minister to verify participation in church activities.

The voucher awards are as follows:

- Full-time student (FT): Grades 11-12 (\$3,000)
- Full-time student (FT): PreK 2-5 full days/FT Grade K-10 (\$2,000)
- Part-time student (PT): Pre-Primary 3 full days (\$1,200)

Part-time status requires a three (3) class minimum
