## RELEASE AND WAIVER OF LIABILITY REGARDING PARTICIPATION IN VOLUNTARY YWCA SPONSORED ACTIVITIES

I, for myself, and for my heirs, assigns, successors, executors, administrators and legal representatives hereby release and agree not to sue the YWCA, the Central Middle School, Town of Greenwich, and their respective employees, officers, agents, representatives and assigns (the "<u>Releasees</u>") from any and all liability, allegation, judgment, cost expense, reasonable attorney's fees, cause of action, loss or damage whatsoever, including, without limitation, death or injury to any person or damage to property, resulting from and/or arising out of my participation in and/or transportation to the Activities even if due to the negligence of the Releasees.
