- Set up begins at 6 pm. Sunshine Cabaret hours: 7-9 pm
- Booths are maximum 10'x10'. Vendors must supply their own tables & chairs. Booth coverings, canopies, umbrellas, or tents are strongly recommended.
- **LOTS OF LIGHTS All vendors will require lights.** LED lights (such as Christmas lights) are the only acceptable type that can be plugged into available (city) power outlets. Otherwise, vendors must supply some form of battery power.
- Vendor fees are non-refundable and are non-transferable.
- Vendors **MUST** be set up by 6:30 pm and must not take down until 9 pm. All vehicles must be moved to the designated parking area by 6:30 pm. All vendors or support vehicles not in designated areas will be subject to City of Penticton bylaws including timed parking.
- Food Concessions **MUST** carry Limited Liability Insurance, Food Safe, and be registered with the Regional Health Authority with their Short Term Food Permits.

NOTE: Copies of all permits **MUST BE** provided to the DPA prior to admittance to the market. Approved vendors are solely responsible for products, equipment, and other possessions, and for their business practices. By making application to Sunshine Cabaret for vendor status, the vendor agrees to indemnify and save harmless Sunshine Cabaret, Downtown Penticton Association and its directors, employees, and agents from any loss incurred by the vendor or from any action or claim of any nature by any person. The vendor also agrees to abide by the Rules and Regulations set out by Sunshine Cabaret.
