Additions and Corrections to the Specifications

Section 10 51 13 METAL LOCKERS

- a. Part 3.5- Schedule, B- CHANGE "18 inches high" to "18 inches to 20 inches high".
b. CLARIFICATION: There are (181) double-stacked units in Corridor 202 (362 lockers total). There are (119) single-stacked units in Corridor 202 (119 lockers total). There are (88) triple-stacked units in Lockers 115DA & 115GA (264 lockers total, 132 lockers per room). There are (40) double-stacked units in Lockers 115DA & 115GA (80 lockers total, 40 lockers per room).

Section 12 66 00 TELESCOPING STANDS

- a. Part 2.4, B, 2 & 3: CLARIFICATION: Telescoping bleachers require end panels when the stands are closed, and vinyl side curtains when stands are open.

Additions and Corrections to the Drawings

Sheet A404

- a. Views D1, E2, and E3: CHANGE 12"x12"x54" note to 12" x 12" x 60" +/- (height may vary by manufacturer).

Sheet A441

- a. CLARIFICATION: There are (6) climbing ropes.
b. CLARIFICATION: There are (3) volleyball systems, 1 for each court.
