

## **CLARIFICATION NO. 1 FROM THE GSA**

Relating to Procurement Procedure GSA/OP/20/14 "FRAME - Framing the definition and development of new PRS use cases based on innovative technologies"

Due to a change to the template of the Legal Entity Form referred to by link in the tender documents, each tenderer, including each member of their consortium and each of their subcontractors, are requested to **ONLY** use the template below for the submission of their tender (to be included in **Envelope 1** of the tender).

Each Legal Entity Form submitted shall be accompanied by a copy of the following supporting documents:

- (1) a copy of the VAT registration document if applicable and if the VAT number does not appear on the official document referred to at (2) below
- (2) a copy of some official document (official gazette, company registry etc.) showing the name of the legal entity, the address of the head office and the registration number given to it by the national authorities.

The **same requirement** shall apply in case of submission of the signed **NDAs for access to Non PRS and PRS information** (section 2.23 of Annex I – Tender Specifications).

Requests for access to Annex I.J may continue to be submitted on any of the two versions of the Legal Entity Form, with no need to submit supporting documents, whereas the GSA reserves the right to request further information, in case of doubt of the required registration in an EU Member State.
