INVITATION TO BID 13-MC-2171 ADDENDUM NUMBER ONE June 19, 2013

THIS ADDENDUM MUST BE ACKNOWLEDGED.

THIS ADDENDUM SHALL BECOME A PART OF THIS SOLICITATION. Amend Invitation to Bid 13-MC-2717 as follows:

Scope of Work/Specifications

Whittier Elementary School, Project Scope:

- 1. Information Technology-related Air cooling System
- 2. Building code Issues Inclusive
- 3. Building Remodel/Renovation Inclusive
- 4. Level 1 ADA
- 1. HVAC Inclusive: Information Technology- related Air conditioning System (MDF Room on 2nd Floor)

The scope of work includes:

- removal of the "mini" split units and installation of the following:
 - o Air handler
 - o Condenser unit
 - low ambient controls
 - All other controls (T-stat)
- Identify all associated work required to complete base scope.
- Provide temporary cooling for this room while doing the work.
- Locate new equipment on east wall at north end, moving shelves to the south.

2. Building Code Issues Inclusive

The Scope of work includes correction of the following deficiencies:

- Deficiency: Office located in exit discharge
 - Location: Custodial office H120A
- Deficiency: *Duct is located in stair*
 - Location: Basement exterior exit discharge
- Deficiency: Air is conveyed through "rated" corridor. Connections are from the classrooms to the corridor.

Location: All corridors

- Deficiency: *Boiler room exits through electrical room* Location: *Boiler room / electrical room*
- Deficiency: No exit signs
 - Location: Balcony and stage, also auditorium

Code compliance: The A/E is responsible for compliance with current code, and for coordinating code analysis and code compliance with the appropriate Authorities Having Jurisdiction (AHJ).

- 4. Building Remodel/Renovation Science Lab Inclusive
- Identify all locations to be included in the remodel use existing building plan room numbers. This would include areas needed to make up for inadequate program areas.
- Identify all safety issues needing to be corrected.

5. ADA-deficiencies:

The Scope of work includes correction of the following deficiencies:

- Exterior bus loading zone, on 25th Ave. Not enough of an Access Aisle.
 Signage, there is no directional signage in place.
- Level 2- IMC room: Maneuvering clearance at door in alcove
- Toilet Rooms- level 1, boys restroom, H-100C, and girls restroom, H100C maneuvering clearance at pull side.

Wyman Elementary School, Project Scope:

- 1. HVAC Inclusive
- 2. Information Technology-related Air cooling System
- 3. Building code Issues Inclusive
- 4. Building Remodel/Renovation Inclusive

1. HVAC Inclusive:

The scope of work includes:

- Identify all equipment and locations of equipment use existing building plan room numbers and equipment identification.
- Scope of work to include replacement of the following:
 - Replace designated equipment described below:
 - All equipment is located in Room 111C, in the southeast corner of the first level.
 - General scope of work to include removal and replacement of boilers, pumps, absorber/chiller, domestic hot water tank, and condensate receiver tank.
 - o Identify all consequential work required to complete the base scope.
 - Replace absorber with new chiller
 - Replace 2 steam boilers with 2 hot water boilers (Aerco Benchmark)
 - Remove condensate receiver. Converter can be removed.
 - Replace domestic hot water heater, with a new domestic hot water heater (Aerco Innovation).
 - Include recommissioning of the new systems in the scope of work.

2. Information Technology related Air Cooling System

The scope of work includes: Information Technology- related Air conditioning System (MDF Rooms)

- Identify all equipment and locations of equipment use existing building plan room numbers and equipment identification.
- The scope of work includes removal of the "mini" split units and installation of the following:
 - Air handler*,
 - Condenser unit*,
 - Low ambient controls*.
 - All other controls (T-stat) provided by GC.

- Identify all associated work required to complete base scope.
- Provide temporary cooling for this room while doing the work.
- Locate new equipment on south wall where the existing system is.

3. Building code Issues Inclusive:

The scope of work includes to fix the deficiencies listed below:

- Stairways are not one-hour rated construction. Fire doors are not provided at stairways.
- Transfer grills are located in corridors, entire building.
- The 2^{nd} floor corridor is open to the IMC, affects the second floor.

4. Building Remodel/Renovation Inclusive

The scope of work includes: Building Remodel – Science Lab Inclusive

- Identify all locations to be included remodel use existing building plan room numbers. This would include areas needed to make up for inadequate program areas.
- Identify all safety issues needing to be corrected.

If your proposal has been submitted and you wish to amend it, please modify your proposal on company letterhead. <u>The amended proposal must be received prior to or included at the time</u> and date set for the proposal opening. Each modification submitted to the District's Purchasing Office located at 1350 E. 33rd Ave. Denver, CO 80205.
