RE: Staff Legal Counsel

RECOMMENDATION

Staff recommends that the Governing Board approve the list of qualified firms, authorize the Executive Director to execute an agreement with each of the listed firms, and authorize expenditures for a total amount not-to-exceed \$150,000.00.

### **BACKGROUND**

Staff has reviewed the qualifications of the firms that requested to be considered for staff legal counsel. All of the firms were judged to be well qualified although the range of expertise and other capabilities varied significantly. In the opinion of your senior staff, the most prudent course is to engage all of the firms and to make assignments based on factors including:

- Experience in the particular specialty needed,
- Expected total cost,
- Availability of counsel, and in some instances,
- Proximity to the District or the subject of the work.

The not-to-exceed amount reflects the amount remaining in the legal services budgets of the departments and the Executive Office, minus an amount expected to be needed to compensate Governing Board Counsel. Staff will provide the Governing Board with a monthly report of legal expenses so that members can monitor the use of these services. I anticipate returning to the Governing Board in October with an initial assessment of this arrangement and a recommendation for the 2011-2012 fiscal year.
