GIFT AID FOR UK TAX PAYERS ONLY

Gift Aid is a simple and straight-forward scheme set up by the UK Government to allow charities to claim tax relief on gifts from those who pay UK Income Tax and Capital Gains Tax.

Winchester College can reclaim basic rate tax on your donation, which will add an additional 25% to the value of your gift.

If you pay higher rate UK tax, you will be eligible to claim additional tax relief thus significantly reducing the net cost to yourself.

GIFT AID DECLARATION:

- I request the Warden and Scholars of Winchester College to treat all donations I make from this date and four years prior, until I notify you otherwise, as Gift Aid declarations.
- I confirm I have paid or will pay an amount of Income Tax and/or Capital Gains Tax for the current tax year (6 April to 5 April) that is at least equal to the amount of tax that all the charities and Community Amateur Sports Clubs that I donate to will reclaim on my gifts for the current tax year. I understand that other taxes such as VAT and Council Tax do not qualify. I understand that Winchester College will reclaim 25p of tax on every £1 that I have given.

Donors must cancel this declaration if, in future, they no longer pay sufficient tax on Income and/or Capital Gains.
