A \$50 non-refundable deposit fee to hold date will be due at the same time. Minimum 2 hour reservation for full clown makeup.

Terms of Agreement

Deposit Fee: A \$50 non-refundable deposit fee will be due on confirmation of booked event. Deposit fee must be received via mail or PayPal, along with a signed copy of this agreement, no later than 14 days before date of event. This is to ensure guaranteed services on date and time of event. If by mail, please mail either check, cashiers check, or cash to address below.

On date and time of event, the remainder balance of \$ _____ is due **prior** to entertainer's start time.

Cancellation Policy: Deposit fee will be refunded only if event is cancelled 14 days before date of event. Any cancellation after the 14 days prior to event will result in no refund of \$50 deposit fee.

Rain or Shine: Bookings are not subject to weather. If your event is outside, I recommend having an alternate location available. Cancellation on day of event due to weather will result in loss of \$50 deposit fee, however, you may reschedule another event within 30 days of event date with no additional deposit fee, if availability permits.

Adult supervision: My services are not to be treated as child care. Responsible adults must be present at all times. Balloons and balloon pieces pose a serious risk of suffocation and choking, especially for those ages 5 and under. Adult supervision is required as I do not recommend giving balloons to those ages 5 and under. As part of this agreement, you accept any and all risks associated with the safety of those attending your event.

Working space: Please provide 1 chair and 1 table no smaller than 4 feet long for the entertainer as well as adequate space for performance. If table and chair not available, please let the entertainer know prior to event date to prepare and provide my own accordingly.

Parking: Please reserve one parking stall for entertainer to park at event venue.
