At that time the owner can enter into a new Consignment Agreement and an additional consignment fee will be due.

Term of this Consignment Agreement for off-site listings is 60 days or until the vehicle sells. During this period we have exclusive rights to sell the vehicle or item. If the owner wants to help sell the vehicle by advertising on their own our contact information must be used in all such advertising and the cost of such advertising will be the responsibility of the owner.

Please provide the following information about the vehicle or item you are consigning to us.

- * Engine size, Transmission, Tire Size, Options, etc.
- * A detailed description of the vehicle, i.e. Condition of vehicle, color, any repairs done and when, any modifications done and any aftermarket items that have been added to the vehicle. The more detail the better.
- * Up to 10 pictures of the vehicle or item.
- * Your complete contact information. Phone, Address, Email address etc.
- * Copies of the paperwork on the vehicle. Registration, Bill of Sale, etc. These will be returned to the owner at the competition of the agreement.

We will provide the following.

- * The vehicle or item will be listed on our Surplus City Vehicles Sales web site. This site is also linked to all our other sites. We have been in business for almost 60 years and between our 3 Jeep parts web sites have over 1,200,00 hits or 39,000 unique visits each month.
- * Vehicle could in addition be listed on several other web sites like Craigslist, cars.com, autotrader.com and depending on the vehicle several other sites.
