Session Fee Payment

Session Fee: \$_____ Upon your execution of this contract and payment of your session fee, Valerie Bruder Photography shall reserve your session time, date and location(s) as mutually agreed upon by the parties. You will receive an e-mail confirmation once your session has been scheduled. No portrait session will be scheduled in the absence of a confirmation e-mail.

Acceptable forms of payment for your session fee include cash, check, money order, or credit card (American Express, Discover, Visa or Mastercard).

Cancellation and Rescheduling of Sessions

Please note that your session fee is non-refundable. In the event that you cancel your portrait session after it has been scheduled, <u>no refund</u> of your session fee will be made to you. However, as we understand that schedules may change, in the event that you need to reschedule your session <u>and</u> you provide at least twenty-four (24) hours advance notice of same, your session fee may be applied to your rescheduled session. Requests to reschedule a session with less than 24 hours advance notice will result in a forfeiture of your previously paid session fee and will therefore require the payment of another session fee prior to rescheduling.

Session Fee – What is included?

The session fee includes (i) a 1 to 1.5 hour photography session for up to four (4) people and/or pets, although additional individuals and/or pets may be included in the session for an additional fee of \$20 each; (ii) professional retouching of ten (10) to fifteen (15) images as selected by the photographer; and (iii) access to a private, online gallery which will be maintained for two (2) weeks so that you may review your retouched images and choose images for print. Your session images will be available for review in your private online gallery within fourteen (14) days of your session.

Session Fee – What is NOT included?

Your session fee does not include any costs associated with the final processing and publication of any portraits that you may select for purchase, including but not limited to the printing, processing, framing, mounting, delivery and media costs associated with same. Because Valerie Bruder Photography works with each of its clients to individually develop an images portfolio that meets with such client's stated intentions and desires, the fees associated with your portraits portfolio will be determined and memorialized under the terms of a separate contract.

Terms of Contract

By your entering into this contact, you acknowledge that Valerie Bruder Photography shall provide the requested photography services to you to the best of its abilities based upon your selected portrait session. Every effort will be made to assure your satisfaction in accordance with accepted industry standards. However, if, in the sole and final opinion of the photographer, inclement weather or other adverse conditions prevent the occurrence of a portrait session that is acceptable within the artistic standards of Valerie Bruder Photography, the photographer may elect to use an alternate location or to reschedule the portrait session at no cost to you.

It is understood and agreed that Valerie Bruder is the exclusive photographer retained to perform the requested portrait services, although the photographer reserves the right to retain the services of individuals to assist her in completing your requested portrait session, at no additional cost to you.

Please note that some venues place limitations and restrictions on photography. <u>It is your responsibility to notify the photographer of such restrictions and/or to gain permissions for requested images outside of the venue's standard restrictions</u>. Valerie Bruder Photography cannot be held responsible for the results of such limitations. However, we are pleased to assist you if you should have any questions or concerns regarding any restrictions that may be communicated to you by or on behalf of any venue.

If Valerie Bruder Photography cannot perform this contract due to fire or other casualty, act of nature, or other cause beyond the control of the photographer, or due to the photographer's illness or emergency, then Valerie Bruder Photography shall refund your deposit and shall have no further liability with respect to this contract. This limitation on liability shall also apply in the event that photographic images are damaged in processing, lost through camera malfunction, or otherwise lost or damaged without fault on the part of the photographer. In no event shall Valerie Bruder Photography be liable to you for any amount in excess of your session fee.

All images and copyrights are the exclusive property of Valerie Bruder Photography. Valerie Bruder Photography retains the right to use, copy, display and/or publish any or all of the images taken during any portrait session for portfolio use to the general public for any reason, including but not limited to website and blog usage, internal and external advertising and marketing usage, promotional materials, educational and product demonstrations, and image competitions, whether or not any such usage is for monetary gain.

By entering into this contract, you warrant that you have the authority to agree to the use of the likeness of all persons included in any photographic images that may be taken during your portrait session, including all individuals who may be included in any group images that you may request, and that you shall indemnify and defend Valerie Bruder Photography in the event of litigation arising out of such use of any such image.

Any modifications of this Contract must be in writing and signed by both parties.
