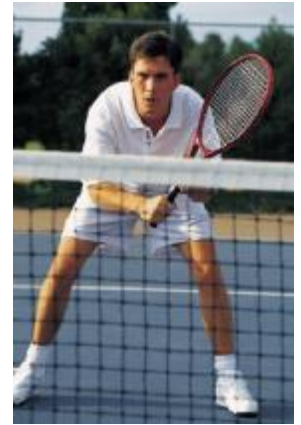


# 2014 Homestead Summer Tennis League Information & Sign Up



## 2014 Summer League Info & Rules—NON-FIXED PARTNERS Same format as last summer.

- Dates:** June 2nd—August 15th, 2014 (No Leagues the week of June 30– July 4)  
**Times:** League play is from 8:30-10am  
**Cost:** \$25 for members \$125 for non-members  
**Sign Up:** 5/5 for Homestead Homeowners and 5/8 for Non-Resident Members and 5/12 for Non-Members  
**Rules:**
- You must sign up in your NTRP level.
  - You may only sign up for yourself.
  - All leagues are non-fixed partner format.
  - Players will move up or down (ladder) according to their weekly results.
  - You are responsible to attend every week, if you are unable to attend, you must find a sub. If you can not find a sub, you will be charged a \$15 no sub, no show fee.
  - Subs who are non-members must check in at the front desk, sign a liability waiver, and pay the \$10 guest fee.
  - Subs must play at or above their NTRP level.

## NTRP Rankings

- 3.5 -** This player has achieved improved stroke dependability with directional control on moderate shots, but still lacks depth and variety. This player exhibits more aggressive net play, has improved court coverage and is developing teamwork in doubles.
- 4.0 -** This player has dependable strokes, including directional control and depth on both forehand and backhand sides on moderate shots plus the ability to use lobs, overheads, approach shots and volleys with some success. This player occasionally forces errors when serving. Rallies may be lost due to impatience. Teamwork in doubles is evident.
- 4.5 -** This player has begun to master the use of power and spins and is beginning to handle pace, has sound footwork, can control depth of shots, and is beginning to vary game plan according to opponents. This player can hit first serves with power and accuracy and place the second serve. This player tends to over hit on difficult shots. Aggressive net play is common in doubles.

### League Ladder Explanation for 2014

Players play one set no-ad scoring (receivers choose) with each player on their court, tie breaker played a 4-all. Set is first to 5 games. Player with the most games won on your court moves up (or stays if on top court, court 1) and the player with the least games won moves down a court (or stays if on bottom court, court 4). The other two players stay on the same court for their match the next week.

Tie is decided by spinning the racquet, or player who was on the higher court or had more games the week before. Subs points can hold a players spot or move them down, but cannot move them up.
