	REPLACEMENT PASSPORT CHECKLIST:
1	United States Passport In Need of Replacing - Replacement passports are for adults whose passports were issued within the last 12 months <u>and</u> have had a name change during that same time period. If it has been more than a year since your passport was issued you must apply for a Passport Renewal. Replacement Passports are used for name changes or correct any descriptive data errors.
2	<ul> <li>Digitally Typed and Printed State Department DS-5504 Passport Application (PART 2 on our site)</li> <li>This online application can also be found here - https://pptform.state.gov/ (handwritten form NOT acceptable)</li> <li>Go Past the privacy disclaimer – and on the next page click SUBMIT under "Apply Online"</li> <li>Enter all passport information requested by the State Department – red asterisk fields required</li> <li>"Summary of Fees" page (only check \$60 Expedite at Agency Fee &amp; \$0 Passport Book Fee) click SUBMIT</li> <li>"Next Steps" Page – Scroll to the bottom of the page and click CREATE FORM</li> <li>Your completed Passport Application form will open as a PDF document, PRINT IT OUT</li> </ul>
3	<b>Two Recent Passport Photos</b> - Go to your local Kinko's, CVS, or Photo Shop (Do not staple your photos to the form)
4	<ul> <li>Proof of Travel Departure (Include <u>one</u> of the following)</li> <li>One clear photocopy of an Airline Plane Ticket Confirmation with your name as the passenger</li> <li>If driving across the border include a copy of a foreign hotel reservation with your name as the guest</li> <li>If traveling for business you may type a company letter (see sample) www.urgentpassport.com/cloe/</li> </ul>
5	Photocopy of I dentification (Include <u>one</u> of the following) - One clear photocopy of your valid state issued Driver's License, State ID Card, or Military ID
6	Government Fee of \$60.00 - Passport Fee must be paid with a <u>Personal Check or Money Order</u> payable to "US Department of State" - Write your date of birth in the memo portion of your check or money order - The check or money order must be clearly written - illegible writing, scratch outs, or post dates get rejected
