Bids shall be evaluated and adjudicated in accordance with the Municipal Supply Chain Management Policy, Preferential Procurement Policy Framework Act 5/2000, responsiveness to bid document (s), and on a 90/10 points system, of which the 90 points for price will be determined as follows –

- (40) for price and (50) functionality as follows :
 - (15) Consultant's relevant experience to the assignment
 - (15) The quality of the methodology
 - (10) The qualification of key personnel
 - (10) Transfer of knowledge
- Proposals/Bids that do not score 40 percent for functionality shall be disqualified and not considered for further evaluation.
