ELIGIBILITY:

Submitting firms must be located within the geographic boundary of the IIDA Texas Oklahoma Chapter. Each entry must recognize all firms and individuals involved in the design process. It is the responsibility of the entrant to give proper credit where joint ventures, firm name changes or former partnerships are involved. Entries that have previously received an IIDA Texas Oklahoma Chapter Design Excellence Award will not be eligible.

Disputes regarding credits may result in disqualification. The project cannot have been a previous winner in the category in which it is being submitted. The project must have been completed after January 1st, 2011.

CATEGORIES:

Each project can be entered in only one of the following categories:

1. **CORPORATE:** This category includes commercial buildings for businesses and corporations.
2. **GOVERNMENT:** This category includes the following areas of practice: Administrative Buildings, Cafeterias/Dining Halls, Courtrooms, Correctional Facilities, Dormitories and Military Base Lodging, Family Service Centers, Libraries, Museums, Officer's Clubs, Office Buildings and Campus Locations, Schools and Universities.
3. **HEALTHCARE:** This category includes the following areas of practice: Hospitals, Medical Clinics, and Medical Laboratories.
4. **HOSPITALITY:** This category includes the following areas of practice: Hotels, Resorts & Retreats, Restaurants & Bars, Country Clubs & Athletic Clubs; Trains, Cruise Ships & Airplanes; Amusement Parks & Entertainment Venues; Convention & Conference Centers.
5. **INSTITUTIONAL / EDUCATIONAL:** This category includes the following areas of practice: Schools, Colleges & Universities, Museums, Libraries, Recreational areas, Family service centers, and Religious Facilities.
6. **RESIDENTIAL:** This category includes the following areas of practice: Homes and Multi-Family Housing.
7. **RETAIL:** This category includes spaces designed for the sale of goods or commodities.
8. **SUSTAINABILITY:** This category focuses on Innovation in Sustainability to award projects with exceptional performance above the requirements set forth by the LEED Green Building Rating System and/or innovative performance in green building categories not specifically addressed by LEED.

JUDGING:

The jury for the competition is selected by the IIDA Texas Oklahoma Chapter Board of Directors. The judging will be performed in advance of the IIDA Texas Oklahoma Chapter Conference. The Chapter Board, the Design Excellence Awards Committee, or the jury may make any interpretations necessary to carry out the intent of the competition, to recognize the highest quality and achievement in interior design, and honor the creativity and innovation of the best Texas and Oklahoma interior designers. Judges reserve the right to abstain from awarding a category if they feel the entries are not exemplary. The judges will award no more than once Design Excellence Award and more than one Honorable Mention in each category. Entries will be judged on the success with which the project has met its individual requirements, overall design quality, and its achievement of excellence in one or more of the following innovations:

ENERGY INNOVATION: Demonstrate exemplary energy efficiency by integrating daylighting, employing innovative electrical lighting techniques, and controlling unwanted glare and heat gain through innovations in window design/treatment and other means.

SECURITY INNOVATION: Demonstrate exemplary planning and execution toward facilitating evacuation and controlling access, necessary for security in schools, hospitals, and other buildings.

SPECIAL NEEDS INNOVATION: Demonstrate exemplary attention to the needs of special populations, implementing interior design solutions that will serve as models for subsequent projects with similar focus.

INDOOR AIR QUALITY INNOVATION: Demonstrate exemplary attention to the habitability of interior space by addressing issues such as mold, off-gassing, temperature and humidity to protect the health and provide for the comfort of residents/employees/visitors.

INCREASED PRODUCTIVITY INNOVATION: Demonstrate exemplary focus on human productivity as it relates to broad planning concepts as well as ergonomic details, and may include innovations in providing natural light and view or other conditions that increase productivity.

ENVIRONMENTAL IMPACT INNOVATION: Demonstrate exemplary social responsibility relative to material use, installation and construction techniques, and careful monitoring of transportation/shipping requirements.

AWARDS & RECOGNITION:

Winners will be notified in advance, will receive recognition, and will have their projects displayed at the IIDA Texas Oklahoma Chapter Annual Awards Gala to be held in Dallas, Texas on August 10th, 2012. In addition, the Chapter will publish the winners in Chapter publications and will seek additional publication opportunities in other regional and national publications.

SUBMISSION REQUIREMENTS:

Enclose each complete entry, with the exception of the entry fee in a separate envelope. The package of multiple entries may then be enclosed in an outer envelope with the entry fee.

- Design Statement

ENTRY NUMBER:

An Entry Number is obtained by calling the Chapter Office (see information on the following page) and registering your intent to enter each project. This number will register and identify each submission.

This entry number should be shown in the following locations:

- On the Entry Application in the appropriate blank.
- On the disk(s) or electronic files.
- At the top of each slide.

POWERPOINT TEMPLATE:

Along with the Entry Number, the Chapter Office will also provide a PowerPoint template that must be used for each project submittal. Instructions within this file are to be followed; any deviations from the template will result in disqualification.

FEATURE IMAGES:

In addition to including images in the slide template as instructed, all images must also be submitted as separate files. These images must be in a high resolution TIF (.tif), JPG (.jpg) or EPS (.eps) format for use in potential publications in the event that the project is selected for award.

DESIGN STATEMENT:

A brief description of the project requirements and the design solution, with no indication of the designer or firm on the page or in the description, will be included. The Entry Number and Project Name must be at the top of the slide, and must be the only identification on the page. The Design Statement should emphasize special challenges and how they were addressed by the design. Additionally, describe how well the project demonstrates Health, Safety and Welfare to the public through inclusion of design strategies utilized and the associated benefits to human needs and well-being.

ENTRY APPLICATION:

For project entries whose design team has a designer that is an IIDA member, the non-refundable entry fee is \$150 per entry. For project entries whose design team has a designer that is a non-IIDA member, the non-refundable entry fee is \$250 per entry.

Entries can be submitted on a CD or USB drive or you may submit digitally through DropBox or YouSendit or other fileshare sites. Please share your file with the email chapter@iida-tx-ok.org. When sending digitally please be sure to send each entry separately as a .zip file with the PowerPoint, design statement, images and Entry form included.

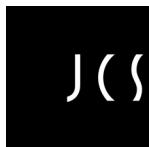
