# Miss Point Mallard's Outstanding Teen Pageant

The third annual Miss Point Mallard's Outstanding Teen Pageant at Point Mallard Park in Decatur will be Saturday, July 3, 2010 on the Spirit of America Stage. Competition is open to young women between the ages of 13 and 16 and the winner advances to Miss Alabama's Outstanding Teen competition in Sylacauga in March 2011.

The pageant is part of the annual Spirit of America Festival. Competition is limited to the first 20 young women who submit completed paperwork and the non-refundable \$100 entry fee by Saturday, June 26, 2010. The earlier you submit, the better!

The 2010 pageant will feature reigning Miss Point Mallard's Outstanding Teen Katie Gilhooly and Miss Alabama's Outstanding Teen Scarlett Walker.

The winner will receive an official Outstanding Teen crown, flowers and have her entry fee for the state pageant paid.

#### **PAGEANT PARTICULARS**

**Saturday, July 3, 9 a.m.:** Contestants arrive at Point Mallard Ice Complex at Point Mallard Park for orientation. Because rehearsals begin immediately following orientation, we ask that you come dressed in shorts, a T-shirt of your choice and tennis shoes. Your pageant T-shirt will be issued at orientation. Parents can attend.

**9:30 a.m.:** Rehearsal on Spirit of America Stage (fitness, talent, gown walk, opening and closing numbers) Parents cannot attend.

**11:30 a.m.:** Lunch at T.C. Almon Recreation Center at the park. Parents should be at the recreation center no later than noon to pick you up.

**Noon:** Travel to Holiday Inn to prepare for interviews.

1:30 p.m.: Interviews begin.

**Approximately 5:30 p.m.:** Travel to Spirit of America Stage for dinner and pageant preparation. Parents are not allowed backstage. Pageant committee members will assist you in getting your competition wardrobe, props, etc. backstage and for helping you dress, if necessary. You are responsible for your own hair and makeup. No outside help is permitted.

**7 p.m.:** Competition begins. Our theme this year reflects Katie's love of sports.

**For opening number, you will need:** a pair of blue jeans (please, no rhinestones or other embellishments), a jersey or T-shirt from your high school, favorite university or professional sports team, and strappy sandals with heel.

**For fitness, you will need:** black Spandex shorts; black fitness shorts, a sports bra, a red tank top, white ankle socks, white tennis shoes and a red or black hair ribbon.

Your costume for talent as well as your evening gown should be age-appropriate.

#### PHASES OF COMPETITION

8-minute private INTERVIEW: This is your opportunity to meet the judges and let them get to know you. You will need to wear an outfit that expresses your personal style and is reflective of today's teen. Suits, dresses and slacks/top are perfectly acceptable. Shorts and midriff tops are not. During the interview you will be asked questions from the interview sheet, as well as questions that deal with national, state and local interests. Be prepared! When preparing your interview sheet, please make sure it is neat and on ONE PAGE. It will be seen by the judges exactly as it is submitted to the Miss Point Mallard's Outstanding Teen Pageant. (Percentage of score: 35%)

FITNESS COMPETITION: On pageant day, we will teach you a brief physical fitness routine. You will perform it in groups of three and individually. (Percentage of score: 10%)

TALENT COMPETITION: Your talent selection must be no longer than 90 seconds. Send a CD recording of your music with your paperwork. Please be sure your recording is of good quality. If you are an instrumentalist, you do not need to send a copy of your music. (Percentage of score: 35%)

ON-STAGE QUESTIONS: Competition will take place while you are in your opening number outfit. The questions will deal with national, state or local interests. Be prepared by becoming familiar with surrounding area as well as current issues. (Percentage of score: 5%)

EVENING GOWN: This is a very glamorous part of the competition and will be the last phase of competition. (Percentage of score: 15%)

Refer all appearance requests to the director or assistant director.

Refer all press, radio or television requests to the director or assistant director.

Honor and fulfill all scheduled appearances.

Prepare herself to successfully meet requirements of approved appearances.

Prepare herself in conjunction with the Miss Point Mallard director and staff to adequately and successfully compete in the Miss Alabama's Outstanding Teen Pageant.

Be prompt for all appearances. There is never an excuse for being late.

Be courteous at all times.

Will seek no coaching, help or outside advice in preparing for state competition without approval from the director and/or assistant director.

Understands that the director and/or assistant director will be part of the decision-making process when preparing for state competition.

Provides her own wardrobe for appearances.

Understands that although she and her family are responsible for the cost of state competition wardrobe, the Miss Point Mallard's Outstanding Teen Pageant director and/or co-director must approve all competition and production clothing. The same applies to selection of talent, talent costume and talent music.

Will be responsible for selling her own ads in the state pageant program book.

Will have no body piercings other than ears (limit two holes in each ear).

Will have no tattoos.

Must allow the director and/or co-director to become her friend on MySpace and Facebook and agree to remove any information deemed inappropriate.

Agrees to wear her crown only in public and with permission from the director and/or assistant director.

Agrees that when traveling to appearances, she may be asked to ride with the director, assistant director or a committee member and not a parent or family member. Miss Teen's family is responsible for providing transportation to and from appearances unless the pageant committee has made prior arrangements.

Supply a list of extracurricular activities and their meeting dates/times, as well as any known conflicts or scheduled events, so that appearances can be arranged accordingly.

Must be a student in good standing at her school and is in the appropriate grade for her age

Agrees not to participate in any other local, state or national level pageant during her year of service (excludes school pageants).

#### The pageant director and/or assistant director will:

Notify Miss Teen of all contracted appearances within a timely manner.

Screen all appearance requests and protect against undesirable appearances.

Assist in preparation for the role of Miss Teen and her participation in the stage pageant.

Act as a chaperone at each appearance.
