Queensland Radio Circuit Car Racing Association (QRCCRA) is a family oriented club that has been built and is maintained by the club's members. Facility Improvement Deposit

As part of your membership you will be required to pay a refundable \$90 Facility Improvement Deposit (FID). As you contribute you'll earn rebate credits that offset your need to pay the FID the following year (i.e. help out and you don't pay the FID again). The club prefers members to get involved but for those members who don't, you can also choose to pay the FID every year. Should you elect to not renew your membership the following year, the FID will be refunded providing you have fulfilled your responsibilities to the maintenance of the club, details of which can be found below.

Adequate contributions to the maintenance and running of the club are subject to committee approval, however these are examples of how you may contribute to the club:

- ☐ Contribute to club working bees
- ☐ Assist in the running of state and/or national titles as an official or in the canteen
- ☐ Race direct or provide catering at club race meetings
- ☐ Mow, whipper snip, and blow down the track and pit areas
- ☐ Scale delegate and subcommittee positions

On top of the above tasks members may use their skills as builders, plumbers, IT consultants and various other professions to contribute to the improvement of the club and its facilities. Any contribution that is of benefit to the club is appreciated and will be approved by the committee.

Contributions should be recorded using the Facility Improvement Contribution forms available on the club's website and in the race control pigeonholes. Completed forms to be placed in the appropriate pigeonhole in race control for committee member approval.
