

ATF Form 5320.1 Instructions

If you have an NFA gun trust, please reference these key points when filling out your form

- 1- Check option a. "Tax Paid."
- 2- Check "Corporation or Other Business Entity."
- 3a- N/A
- 3b- Enter the name of your trust and the address of the trust.
- 3c- If applicable, place non-P.O. box address in this location
- 3d- County (not country) of Trust
- 3e- Your phone number
- 4a- The name and address of the manufacturer. If you manufactured the gun, place the name and address of your gun trust here.
- 4b- Type. SBR (Short Barreled Rifle), Silencer, Suppressor, etc.
- 4c- Caliber here. If there is more than one, you must include an additional configuration letter since only one will be accepted in this field. Please see the Amendment to ATF Form 5320.1 in the instruction section of your Trust.
- 4h- N/A unless there is an inscription on the gun, then put that inscription here.
- 4i- Print or type, "All lawful purposes" in this box.
- 4j- Check "no."
- 5- N/A
- 6- N/A
- 7- Your signature
- 8- Print or type the name of the trustee on the trust followed by (Trustee).
- 10 and 11- Truthfully answer all these questions. If you answer yes to any of these, you will likely be denied the ability to purchase a firearm.
- 12 and 13- Leave the rest of the page blank as it isn't required with a gun trust.

Important Information for Currently Registered Firearms

If this registration document evidences the current registration of the firearm described on it, please note the following information.

Estate Procedures: For procedures regarding the transfer of firearms in an estate resulting from the death of the registrant identified in item 3, the executor should contact the NFA Branch, Bureau of ATF, 244 Needy Road, Martinsburg, WV 25405.

Interstate Movement: If the firearm identified in item 4 is a machinegun, short-barreled rifle, short-barreled shotgun, or destructive device, the registrant may be required by 18 U.S.C. § 922(a)(4) to obtain permission from ATF prior to any transportation in interstate or foreign commerce.

Change of Description or Address: The registrant shall notify the NFA Branch, Bureau of Alcohol, Tobacco, Firearms and Explosives, 244 Needy Road, Martinsburg, WV 25405, in writing, of any change to the description of the firearms in item 4, or any change to the address of the registrant.

Restrictions on Possession: Any restriction (see approval block on face of form) on the possession of the firearm identified in item 4 continues with the further transfer of the firearm.

Persons Prohibited from Possessing Firearms: If the registrant becomes prohibited by 18 U.S.C. § 922 from possessing a firearm, the registrant shall notify the NFA Branch, Bureau of Alcohol, Tobacco, Firearms and Explosives, 244 Needy Road, Martinsburg, WV 25405, in writing, immediately upon becoming prohibited for guidance on the disposal of the firearm.

Proof of Registration: This approved application is the registrant's proof of registration and it shall be made available to any ATF officer upon request.


GETTING STARTED WITH YOUR NFA GUN TRUST

UTAH GUIDE

IS IT LAWFUL TO OWN NFA?

YES, Utah and many other States allow you to own NFA weapons.

What states allow NFA items?



How do I own an NFA weapon lawfully?

There are 3 Ways to own NFA weapons:

- 1. As an Individual; This requires approval from your CLEO (chief law enforcement officer), fingerprints, and a photo.
- 2. As a business: A business can purchase an NFA with out the approval of a CLEO.
- **3.** As an NFA trust: NO CLEO, Multiple people have access and sound estate planning.

Cost of an NFA trust?

Most common NFA trust is about \$400.

What is the cost of an NFA?

Each time you purchase an NFA firearm there is a \$200 tax to the ATF included with the cost of the weapon from your dealer.

Can other people use my NFA weapon?

YES, If you are present with the NFA weapon. With a Trust, those on the trust can take the NFA weapon without you being present.

Can I travel with an NFA?

YES, As long as your NFA is lawful in your final destination. The same restrictions apply for traveling on an airplane for firearms.

Can I move with my NFA?

YES, You must notify the ATF with form 20 (5320.20).

Can I make an NFA item with an NFA Trust?

YES, Your Trust can make and register the above NFA items with a form 1.

Do I notify the ATF when I travel with my NFA?

YES, You must notify the ATF with form 20 prior to leaving your state

Can I make my own NFA?

YES, You can make your own suppressor, SBR or SBS and register it with the ATF form 1.

What is an NFA gun trust?

In its simplest form, a trust is basically a contract between you (the trustor) and another person (the trustee) where the trustee agrees to administer certain items that are held in trust. This special form of contract creates a legal entity that the ATF recognizes as a valid person to possess NFA items – things like full auto machine guns, suppressors and Short Barreled Rifles/Shotguns. There are three huge advantages to having an NFA gun trust set up: (1) it allows for exceptional estate planning where you are able to easily transfer the NFA items to your beneficiaries when you pass away, (2) you are able to have more than one person have access to and possession of your NFA items and (3) there is no requirement to have the chief law enforcement officer ("CLEO") for your area sign off on the NFA item (without a trust, you have to ask your CLEO for permission, submit two copies of fingerprints and two passport photos to the ATF – these things are not necessary with a trust).

What does it cost?

An NFA gun trust to protect your items costs \$200 for the Basic, \$350 for the Advanced and \$550 for the Premium. The Advanced trust fits most people's immediate needs and will serve as an exceptional means of protecting and possessing your NFA items. Not only does this \$350 trust get you a legal trust, but you will also have plenty of time to speak with your Utah gun trust lawyer, Michael Steck, about the intricacies of owning NFA items in a trust. Michael will not only advise you on owning the NFA items in trust, but also help you understand the legal issues surrounding NFA items. Michael is also an NFA firearm manufacturer and can get you whatever suppressor/full auto you are after. Check out some of the NFA firearms his business manufacturers at JoeFirearms.com. Are there any downsides to getting an NFA trust?

The only real downside to starting an NFA gun trust is the initial cost of setting up the trust. As an individual purchaser, you will not pay this amount and just pay the \$200 tax to the ATF for each NFA item. However, if you feel like you would like any of the above mentioned benefits from an NFA gun trust, you should start with getting the trust first rather than waiting until you already have several items. Waiting to get setup with a trust only means headache down the road. It really is in your best interest to start with an NFA trust from the beginning.



Who are the parties in an NFA gun trust?

In setting up your Utah NFA weapon trust, there are several people that need to be identified and listed on your trust. The following information is designed to help you understand who the parties are that are supposed to go into your NFA weapon trust to handle these special firearms.

So here is a basic list of who the parties are in a NFA weapon trust:

<u>Trustor</u>: The Trustor is the person for whose benefit the trust is created. You, the person reading this, are most likely the Trustor as you are probably the person who is going to be buying the NFA item. A Trustor is also called a grantor.

<u>Trustee</u>: You, the Trustor, will also be listed as a Trustee. As trustee, you will have a present right to possess NFA items. You will list all those that you want to have an immediate possession to your NFA weapons as trustee.

<u>Beneficiary</u>: A beneficiary is the person to whom you want to leave your NFA items when you pass away. There is some discussion about whether a beneficiary has the ability to access your NFA weapons in this NFA trust. Michael can discuss this with you when you have purchased the NFA weapon trust.
