Lessor may make written request to tenant by certified mail, return receipt requested for tenant to move the vehicle or trailer to another space for purposes of Lessor's repaving, restriping, general maintenance, facility reconfiguration, or other such purpose. If tenant fails to move his vehicle or trailer by the date and time requested, which may be no sooner than seven days from the date of the mailing of such request, Lessor may have the vehicle or trailer moved to another location in the facility at Lessor's expense. Lessor will promptly notify tenant by mail or phone of any relocation authorized by this paragraph.

*If Lessor seizes the vehicle in the process of performing a foreclosure under Texas Property Code Chapters 59 and 70, Lessor may enter (through use of a locksmith or other reasonable means of entry) the vehicle for the purposes of inventorying its contents and any cost of entry will be Lessee's responsibility. Contents of the vehicle will be sold with the vehicle.*

The undersigned certifies the information in this addendum is true to the best of the undersigned's knowledge and correctly describes the vehicle and trailer (if any) now placed or to be placed in space described above pursuant to the TSSA Self Storage Rental Agreement.

The undersigned acknowledges that failure to pay monthly rent and other sums due under the TSSA Self Storage Rental Agreement can result in foreclosure of the storage facility owner's statutory lien on such vehicle. *Sales tax will be due and collected in accordance with state law.*
