A Community Hero demonstrates how a person with passion and determination can use their life to make a difference in a Toronto Community Housing neighbourhood. We are looking for inspirational individuals that we can recognize at local events, in publications, and online.

Community Heroes can only be selected after being nominated by someone like you, so we encourage you to read the rest of this form, complete it, and submit it to economic-opps@torontohousing.ca

Nominate a Community Hero who inspires you!

Nominator eligibility criteria

To be eligible for consideration each nomination must meet the following criteria:

- Nominator must be at least 10 years old
- A nominator may only nominate one Hero per month. If a nominator submits multiple nominations, only the first submission will be considered
- Nominator must provide the contact information, including email address, and telephone number for the nominee
- Nominator must submit the nomination form in English
- Nominator and nominee will be required to complete a photo release form, should the nominee be selected as Community Hero

Hero eligibility criteria

To be eligible for selection as a Community Hero, a nominee must meet the following minimum criteria:

- Must be a Toronto Community Housing resident
- Must complete a photo release form as a condition to be selected

General rules

- Only eligible nominations received will be considered
- All nominations become the property of Toronto Community Housing and will not be returned
- Nominees may be contacted to verify or provide more information
- Toronto Community Housing may use and edit the nomination information in publications or promotional activities
- If more than one nomination is received for a nominee, Toronto Community Housing will designate one of the nominators to be used in publication or promotion

Tips for writing your nomination

- There is no definition of what makes a Community Hero, but most tend to be unsung heroes who
 are quietly doing amazing work for the improvement of their community and the people who live
 there.
- Describe your Community Hero in a compelling manner so we can share their story with other residents, partners, elected officials, the media, and the public. Inspire us so we can inspire others!
- Include details about how your Community Hero has dedicated his or her time to helping others.
- Include facts and other supporting data where possible, such as the number of people your Community Hero has impacted or the number of hours of service he or she has committed.
- Include details that you believe help distinguish your Community Hero from other Community Heroes who are being nominated. Tell us what makes them different and special.
- Tell us what your Community Hero is passionate about. We want to understand what makes your Hero the amazing person that you believe they are.
