Capitalized terms used in this Authorization Letter, the Master Agreement, customer Guide, Exhibit/Lease Schedule and Master Lease Agreement are defined in the Defined Terms (all these documents are collectively the "Documents"). These Documents can be found at http://www.my.reyrey.com. The Documents are specifically incorporated by reference into this Authorization Letter and made a part hereof. For Your convenience, we are attaching copies of the Master Agreement, Master Lease Agreement and Defined Terms to this Authorization Letter.

To Order Items or Services, You will accept (either in writing or electronically, as specified by Reynolds) the applicable Exhibit/Lease Schedule and forward it to Reynolds in the manner we designate. Your acceptance constitutes an offer pursuant to the Documents that can be accepted by Reynolds. The Exhibit does not become a binding Order until it is accepted by Reynolds in the manner described in the Documents. You agree to the use of electronic means of transmitting and accepting Orders, and that You will follow all rules for electronic contracting set forth in the Documents. In particular, You will be responsible for actions taken using the logins, pins and passwords ("Passwords") and to safeguard and protect any confidential Passwords we may assign You from time to time, as set forth in the Documents, and only allow authorized personnel to use any such Passwords. Reynolds will notify You if Your Order will be handled manually or electronically and You agree to the use of either method. You authorize Us to perform a credit check.

For leasing transactions under the Master Lease Agreement, You assign to Reyna Your right to purchase the Leased Products and license the Licensed Matter, and this Authorization Letter and the applicable Lease Schedule shall act as a bill of sale transferring from Reynolds to Reyna the Leased Products and the Licensed Software under the terms of the Documents which are then leased by Reyna to You under the terms and conditions of the Documents. Upon commencement of your Lease, Your payment obligations for Leased Items will be to Reyna rather than Reynolds. You remain obligated to Reynolds to follow license, use and other restrictions in the Documents. YOU ACKNOWLEDGE THAT YOUR OBLIGATIONS TO REYNA ARE ABSOLUTE, UNCONDITIONAL, AND SEPARATE AND DISTINCT FROM REYNOLDS.

You and the individual signing below agree, represent and warrant that: (1) the name of the Customer entity listed above is the exact name reflected in the public records of its jurisdiction of organization; (2) the undersigned is authorized to sign on behalf of Customer and agrees that this Authorization Letter (including the Documents incorporated by reference) is a binding contract of Customer; (3) the information provided for Customer and all authorized representatives and employees is and will be correct; (4) You have read this Authorization Letter (and Documents incorporated by reference) and Customer will be bound by all terms and conditions described therein, as signified by Your signature below; (5) the agreements, rights and obligations contained in the Documents are separate and distinct and may be separately transferred by Reynolds and Reyna; and (6) any past, present or future document may be executed, accepted and/or delivered in several counterparts via paper, telecopy or electronically, each deemed an original, all of which will constitute the entire agreement of the subject matter therein.
