**SIGNATURE REQUIRED: Read and sign, indicating acknowledgement and acceptance of these terms:**

- If a student starts school and then subsequently withdraws, tuition for the remainder of that semester will still be due and will be drafted using the EFT set up through FACTS Tuition Management.
- Monthly tuition payments will be drafted via Electronic Funds Transfer (EFT) through FACTS Tuition Management.
- An EFT returned for insufficient funds will be assessed a \$25.00 late fee through FACTS Tuition Management.
- Facts will continue to draft the account to recover the tuition payment plus all applicable fees, as stated in the separate agreement families sign at the time of enrollment.
- After monthly tuition payments have started, a \$25.00 fee will be assessed if there is a change in the EFT, including payment method, account drafted, transfer date, etc. The fee will be charged each time there is a change.
- Payor agrees to pay for the full tuition for each semester that the above students begin.
- Families with unresolved delinquent accounts will not be permitted to re-enroll for the following year.
- Student records (including official transcript) will not be released until all delinquent accounts have been resolved.
- Registration fees are non-refundable for re-enrolling students.

**For new applicants:**

This contract is conditional upon the following terms:

**If admission is denied:**

The registration fee will be refunded and this enrollment contract will be shredded.

**If admission is granted:**

The family will have **15 days** after notification by the school to inform BCS if they decide not to enroll.

**After the family accepts**

**admission** or after the **15 days**, whichever comes first:

- This enrollment contract will be executed and
- The registration fee becomes non-refundable.

*Monthly Payments via Electronic Funds Transfer (EFT) through FACTS Tuition Management*
