How to Complete Your Citizenship Certification

- Step 1. Gather originals of citizenship/immigration documents and government-issued photo identification.
- **Step 2**. Bring documents, photo-identification, and a blank copy of Citizenship Affidavit (2016-2017 Certification of True, Exact, and Complete Copy of the Original form) to a notary.
- **Step 3**. Photocopy citizenship documents and government-issued photo identification.
- **Step 4**. Complete Affidavit form with notary, have all forms and documents notarized.
- **Step 5**. Submit completed Affidavit, notarized copies of citizenship documentation, and government-issued photo identification to The Solution Center either via U.S. mail or via email in PDF format (no photographs).

Examples of Acceptable Citizenship/Immigration Documents

- U.S. Passport or U.S. Passport Card
- U.S. Birth Certificate
- Permanent Resident Card or Alien Registration Receipt Card (Form I-551)
- Certificate of Naturalization/Certificate of Citizenship
- Form I-94 or Form I-94A

Examples of Acceptable Government Issued Photo Identification

All documents must NOT be EXPIRED

- State-issued Driver's License or non-drivers I.D.
- Military I.D.
- U.S. Passport or U.S. Passport Card
- Permanent Resident Card or Alien Registration Receipt Card (Form I-551)
