Mail a dated copy of your sales receipt including the serial numbers for both firearms, a copy of page 3 of your BATFE Form 4473 for both firearms (or a signed letter from your dealer, on the dealer's letterhead, stating they refuse to release a copy of the Form 4473) and this promotional form for both eligible FN firearms purchased to: FNH USA 5.7x28mm SYSTEM REBATE, DEPT# FN11-7773, PO BOX 472, SCOTTSDALE, AZ 85252-0472. (The BATFE Form 4473 or Firearms Transaction Record is a U.S. Government document that must be filled out when a person purchases a firearm from a Federal Firearm License holder.)
