WHEREAS, Lynro, LLC dba Hangar 1 Flight Center of Stillwater ("Hangar 1 Flight Center") is a domestic corporation organized under Title 18, Oklahoma Statutes; and

WHEREAS, Hangar 1 Flight Center leases a building from Stillwater to operate a flight training school at SRA; and

WHEREAS, an executed copy of the lease agreement is attached hereto as Exhibit "A"; and

WHEREAS, the term of said lease began on August 1, 2006 and will expire on September 30, 2016; and

WHEREAS, Article II of said lease grants Lynrho, LLC an option to renew five (5) year term commencing October 1, 2011 and ending September 30, 2016; and

WHEREAS, Stillwater and Hangar 1 Flight Center agreed to amend Article II to permit exercise of the renewal option in five (5) one year increments; and

WHEREAS, Section 2-160, Stillwater City Code, mandates City Council approval of any amendment of a lease at SRA.

WHEREAS Hangar 1 Flight Center requests renewal of the lease agreement for the following year as follows: October 1, 2014 through September 30, 2015.
