**Australia's Electricity Sector:
 Ageing, Inefficient and Unprepared, according to Climate Council**

Speaker: Andrew Stock



A landmark report recently prepared by the Climate Council and led by Andrew Stock has reviewed Australia's electricity sector. The report finds Australia's electricity is largely generated by ageing, inefficient coal-fired power plants and there are currently no plans, nor a national discussion on the future of the electricity sector and options to significantly reduce its emissions. The Climate Council states that delaying the shift to a low carbon future increases the likely risks and costs of transition to a low carbon future in the electricity sector, where it typically takes a decade or more to plan, permit, finance and build major new power infrastructure.

Andrew Stock is a Director of ASX listed Horizon Oil Limited, Silex Systems Limited and Geodynamics Limited, a Board Member of Alinta Holdings and the Clean Energy Finance Corporation. Previously, a senior executive at Origin Energy Limited where as Executive General Manager, Major Development Projects, he led Origin's major development and capital investment program of over \$4 billion in upstream petroleum, power generation, and low emissions technology. Andrew has a Chemical Engineering Degree (Honours) from the University of Adelaide with postgrad qualifications from IMD Lausanne, Switzerland, and the University of Western Australia.
