# GM Report

I would like to take this opportunity to thank the PRIDE volunteers for all the long hours and hard work they have put into sprucing up the subdivision during this past year. Most recently, they repainted 330 posts along the dam, plus the bridge railing; all that after spending lots of hours in the blazing sun to cut overgrowth in the spillway runoff channel. This is an amazing group of people who have an extraordinary commitment to improving the infrastructure and appearance of Lake Lorelei!

A REMINDER – SPEED LIMITS in the subdivision were established long ago, with the approval of the State of Ohio, to help insure a safer environment for everyone. Your vigilance in driving at speeds less than the posted limit goes a long way toward keeping vehicles, pedestrians, skaters, bikers and golf carts safe from injury. Your decision to leave the house 2 minutes earlier and driving at less than the speed limit while in Lake Lorelei can mean the difference between being involved in an accident, and even being stopped for speeding (\$50 minimum fine). Someone started the rumor that Lake Lorelei does not have the authority to impose a fine for speeding on our roads. We chose to employ a private security firm to help enforce speed limits; the primary difference from using the Brown County Sheriff is that you may not be **forced** to stop by the private officer. Even if you don't stop, when the officer identifies your vehicle license plate and makes a report of the violation, the LLPOA has the legal right to issue a violation notice for failure to obey our traffic rules. As an alternative to using the private security, we are investigating the option of using the Brown County Sheriff's department. If that happens, a traffic stop will be much more expensive and will cost a couple of points on your driver's license.

**REAL ESTATE SIGNS** may be placed on your lot, but are prohibited on LLPOA road right-of-way (generally from the top of the drainage ditch to the roadway). Only one sign may be placed on each road frontage and lake side frontage. Recently, a number of "For Sale" signs have been placed right up to the roadway (presumably to better attract a buyer). This is in violation of LLPOA Rules. Owners who have a real estate "For Sale" sign displayed off their own property should take action to move it. After a reasonable time, the maintenance department will be authorized to move those signs remaining in the right of way. We should remember that unauthorized signage in the LLPOA right of way may legally be removed and taken to the maintenance building, where a recovery charge could be assessed.

**SIGNS – IN GENERAL**. If you wish to display any sign in your yard, it must be approved, in writing, by LLPOA. That may seem petty, but it is necessary to prevent the subdivision from being overrun with personal advertising of ideas, people, events or products, etc.

**ANNUAL REGISTRATION** – If all goes well, we plan to implement online registration, where you can, by using your computer, update your personal information (address, phone, etc) and provide up-to-date information regarding the vehicles and watercraft you want to register for 2011. This will be done through the website www.lakeloreleiohio.com. Then, when there is a change, you can make the corrections yourself, directly into our database. We'll give you plenty of advance notice and helpful hints on how to use this new system, when it is up and running. I would like to thank you all for keeping your dues and fees payments current. We appreciate your assistance in helping with the necessary funding for the general welfare of all members, family and guests.



# The Lake Report

Another summer has passed and by the time you read this you most likely have most of your water toys put away for the winter. Don't forget that the valve to the Lake will be opened on November 15<sup>th</sup> to start our annual lowering of the Lake. If this is your first year, we open the valve to lower the water level to help protect our docks from being damaged by the water freezing around them. This also gives you a couple months to repair the docks and rip rap along your shoreline. If you have a boat docked in some of the shallower coves, then you especially want to get them out soon after the valve is opened. Don't wait too long as we never know how fast the Lake is going to lower or for that matter, how fast it will fill back up. It all depends if we get substantial rains or snows this winter.

We are all aware of how shallow our coves are becoming and would love nothing better than to be able to dredge them all out. Unfortunately, we do not have near enough funds in our budget for that at the present time. We have had some members get together and take it upon themselves to have their individual coves excavated at their own expense. We appreciate their efforts and contributions to improve the depth of their coves. If you live on one of the smaller coves and are interested in getting your cove members together for such a project, let us know, and we will hook you up with those that can give you some guidance on how this can be done.

This past summer, we have heard several complaints about members leaving their floating rafts in the water when they are not using them. This might not be such a big deal if they were tied up alongside their docks, but we have seen some that appear to be anchored 24/7 out in the coves. Our code says that "docks shall not extend more than twenty (20) feet into the Lake from the normal waterline" to maximize the width of our coves for boat passage. This also would pertain to rafts if it becomes apparent that they are actually "anchored" full time. When we anchor our rafts out in the coves this narrows the cove and makes it harder for boats to navigate safely, especially at night. Don't get me wrong, we all know how much fun the kids (and adults) have on them, we just need to be courteous of others and pull them back in when we are not using them so we are not blocking anyone else's use of the Lake. Take a look at how far your rafts are out into the cove or main Lake and when you are not using them, pull them back up to your dock or at least make sure they are not more than 20 ft. from the shoreline (not the end of your dock). We don't want to have another "rule" for where and when we can use inflatable rafts and we won't have to if we are all courteous of others.

Now put a reminder about the Lake valve on your calendar and get your boats out and winterized before you find them "dry-docked" for the winter!

The Fish Committee has \$2800 of the needed \$3000 toward stocking the fishing lakes with minnow and the main lake with walleye. If you can help, please, contact Tom Iles at 310-1628.

# Treasurer's Report

As we come to the end of the year and reflect back on what has happened in positive ways at the Lake I find necessary to address the opening and success of the Restaurant. If you haven't visited Coconut Joe's yet you might want to do so in the near future - it's a fun and entertaining place to eat. Our neighbor, Jack Ballinger, runs the restaurant.

Jack opened Coconut Joe's late in 2009 after a long period where we had no restaurant at all. For those that do not know, the first arrangement that was entered into with Jack was one where he managed the restaurant as an employee of the Lake. The cooks, waitresses, etc., were employees of the Lake. The management arrangement was set up for a period of 6 months to give both parties the opportunity to get a feel for logistical issues and how the restaurant agreement could be improved. Needless to say during the initial stages of this new business venture there were hiccups with the arrangement. It became apparent that LLPOA was subsidizing the restaurant to an extent the Board found difficult to justify even though Jack has done a wonderful job, creating an enjoyable environment for LLPOA residents. We worked diligently with Jack to reach a new arrangement we hope will be beneficial to both parties.

I will attempt to describe the arrangement we have made to keep the restaurant afloat and growing for the next 6 months. When the Board and Jack sat down to discuss a new contract, we agreed that to move forward it was time to take a different approach with the current contract. Many ideas were put forward and discussed but we agreed the best way to keep our restaurant open was to lease the restaurant premises to Jack and let him operate it for the Board as a lessee. Jack will be responsible for all aspects of the restaurant's operations and is taking ownership of most all cost of the operation. In return, the revenue is his.

The arrangement with Jack that we are finalizing is modeled after the current arrangement with Bob Kiley, our Marina operator. In my opinion this arrangement is a step forward and will bring long term benefits to the Lake Lorelei community just like our arrangement Bob.

As most of you know, it has been very difficult historically for LLPOA to keep the restaurant open and operating. We hope this arrangement keeps the restaurant up and running for years to come. Please support Jack and visit Coconut Joe's.

# CLASSIC CAR SHOW



# LAKE LEVEL

The lake drain valve will be opened on November 15<sup>th</sup>. The water level will lower about 2" per day, if we don't get much rain. When the lake gets to a level about 5 feet lower than normal (after 1 week; 14" lower, 2 weeks; 28" lower, etc.), the valve will be closed, to maintain what is called "winter pool" level. The valve is closed no later than February 15<sup>th</sup> to allow the water level to rise to normal levels. The lake fills up rapidly after a rain - 1" of rain can cause the water level to rise 12" to 13" in a single day.


