LOAN STATUS VERIFICATION (2015-2016)

INSTRUCTIONS: When you filed your Free Application for Federal Student Aid (FAFSA), the FAFSA processor sent you a response indicating their records showed that a previous loan is in default, discharged, or that you have filed bankruptcy. Based on that response, the federal government requires that we obtain information from you to confirm your continued eligibility to receive federal funds. *Incomplete documents will not be returned. They will be disposed of in a secure manner, per university policy. This will delay processing.*

Your loan history from the National Student Loan Data System (www.nslds.ed.gov) may show that your loans are defaulted. You may call the U.S. Department of Education at 1.800.621.3115 for assistance or for information regarding your loan.

We cannot proceed with the review of your financial aid eligibility until you submit a copy of the requested documentation that is appropriate to your situation and it is verified as resolved.

ACTION TO COMPLETE FORM:

Select situation below which is relevant to you and attach a copy of documentation showing that you have resolved your loan status:

- Defaulted Loans** - If one or more of your federal student loans are defaulted, submit this form only after you can attach documentation that the loans are repaid or rehabilitated.
- Active Bankruptcy Claim** - If you have a non-defaulted student loan in an active bankruptcy claim, you will most likely be eligible for aid as long as you do not have any student loans in a default status. Attach your NSLDS loan history to this form to document that all your student loans are in good standing.
- Non-Veteran Disability Discharge** - If you wish to take out additional student loans, attach a physician's certification that you have the ability to engage in substantial gainful activity AND a statement that you signed stating that you are aware the new student loans can't later be discharged for any present impairment unless your condition deteriorates to the point where you become permanently disabled.
 - If you do not meet the three year conditional disability discharge, you must also include a signed statement that you affirm you will resume responsibility to pay back your previous student loans.
- Veteran Disability Discharge** - If you qualified for a disability discharge based on one of the two standards listed below, submit a copy of the documentation that confirms your eligibility:
 - Letter from the VA confirming that you have a service connected 100 % disability; or
 - Letter from the VA confirming that you are totally disabled based on your unemployability determination
