Martin Luther King, Jr.'s Church & Home Tour



We visited the Martin Luther King, Jr. National Historic Site. It was established in 1980 to preserve the places where he was born, lived, worked, worshipped, and is buried. We toured the Ebenezer Baptist Church where Martin, Martin's father, and maternal grandfather all preached. The simple, restored, beautiful church was the center of Martin's life. The stain glass windows were very impressive. At Ebenezer Baptist Church, Martin was baptized and at the age of 19 was ordained as a minister. In 1960 he became co-pastor of Ebenezer with his father, "Daddy" King, and remained in this position until his death in 1968. His funeral was held here as a final farewell to his spiritual home.

We viewed Dr. and Mrs. King's tomb on a brick island in a Reflecting Pool. The Eternal Flame serves as a reminder of the Kings' undying commitment to their beloved community.

We drove by the home, in the historic residential area, where Dr. King was born on January 15, 1929. It was the home of his maternal grandparents. He lived here for the first twelve years of his life.

As we visited this area, it certainly reminded us of what a great leader and crusader for human rights Martin Luther King, Jr. was for all people.

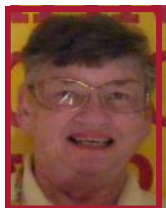

Forks RV Continental Coach

Seminar Day



The seminar started with a couple dozen in attendance; others drifted in during the talk. Eric Stutzman, son of the owner began by explaining the business which is family owned & operated since 1991. The company does customized work & has built their reputation on the integrity of the work. Their business depends on

customer satisfaction and word of mouth is their advertisement. They not only build super high quality coaches but operate a full service department, not only for their Continental Coach customers but for any RV. Several of our club members have already had their Tetons serviced. Call them for an appointment and they will order the needed parts or materials. They may need a few weeks lead time or if you have an urgent issue, will give you an appointment in just a few days. In answer to a question, Eric said that the RV industry in general is coming back but not yet up to the pre 2007 level.

Mike Butler, who was with Mor Ryde & is now their employee, discussed the step by step construction of a new coach. Their brochure detailed 25 points that set their coaches apart from other RV's. Many of our members who have toured their factory are not only very favorably impressed but some have even stated that these coaches are far superior to Teton even when they were at the peak of their quality. I know I was amazed when I saw the steel casing around the wheels. We all know that you can not have a blow out without doing at least some damage to your coach and sadly usually major damage. So until you get your Continental Coach remember to watch the DOT number on your tires and replace them when they are 5 years old no matter how much tread is left. The rubber started to age the day it was manufactured. We like to order our tires and insist that we will not purchase anything more than 3 months old. The secret to decoding the DOT number is to remember that the 4 numbers represent the week of the year (01 thru 52) and the year (00 thru 99). So a tire built this 1st week of May would have a DOT number of 1814; the 18th week of 2014. We have 12 tires on our rig so buying 2 every year for 6 years keeps the cost manageable.

After answering tons of questions Eric, Mike & Kenny started working on our coaches. The Forks RV Company shared the coast of our diner at the Metro Café that evening and worked all the next day until 7PM getting our coaches in better repair. They were our guests that evening at our Italian Buffet.

It is really nice having them as our RV parent! Happy trails, see ya down the road a piece.

Kitchen Slide Roller Replacement



The roller for my kitchen slide has needed replacing for the past year. I kept putting off replacing it hoping it would fix itself. I had heard horror stories of folks removing the cabinet floor to access the roller. The way I saw things, removal of the floor would compromise the entire structure, hence, my hesitation to tackle the project.

So I came up with idea of precisely drilling two 1" holes in the cabinet floor to line up with the roller mount screws. This would allow a square bit attached to a 90 degree drill or screwdriver to access the roller mount screws under the cabinet. (Measure four times, then drill once!) Once the holes are drilled then just move the slide in or out to line up the hole over the screws. When drilling the holes be careful not to drill through the 1x6 board mounted under the cabinet that the roller rolls on. With a square drive remove the mount screws, bring



the slide in so that the cabinet rises slightly and remove roller from under cabinet.



Now that the roller is free, hacksaw the spot weld from one end of the hex shaft, pull up on roller and slide off. Slide new roller on same hex shaft and apply tack weld to hold in place.



Now if the floor where the roller is mounted is sound and does not sag, just reinstall roller and mount. However, if your floor has deteriorated and is not very

sound (this is the case most of the time), a metal plate can be installed to raise the roller slightly (3/16") and spread the weight over a larger area. Buy some 2" x 3/16" steel stock at a hardware store. Cut two pieces 10" long. Mount roller as shown in photo. Drill several holes as shown to screw into floor.



Now slide roller into the existing floor cutout. Install 1 1/2" woodscrews in each predrilled hole to secure to floor. Move slide in and out to align cabinet floor holes to line up with each mount screw.

Once roller is securely mounted to floor, test by moving slide in and out a few times. You may have to do some minor adjusting outside to compensate for the extra height.

Install some linoleum ruminants on the cabinet floor. Holes will be hidden by the linoleum and can be used again if needed.

Kitchen Slide Fix



I am submitting this document for publication in our newsletter, but credit for coming up with the idea, and writing the initial version of this article, belongs solely with Brad Tihinen, a Teton owner and former member of the Teton Club International. He told me about this “invention” and asked me to pass it along to Tetoners who attended the most recent TCI rally. After the rally I volunteered to submit this information for publication in the TCI newsletter, since he is not authorized to submit articles, so many more Tetoners could become aware of this approach, which will help prolong the life of the kitchen slide-out seal, and prevent damage to the kitchen floor when the street-side slide-out is closed.

Problem: The upper right-hand corner (looking from inside the trailer) of the kitchen slide-out tears the seal when it is closed and you are pulling the trailer, the slide-out bends and twists as it is being opened/closed, and the sink cabinet overhang drags on the floor as the slide-out is being closed.

Reason: Most, or all, of these problems are probably because the slide-out support roller does not work or needs to be replaced. Whatever the cause, the slide-out comes in initially at a severe downward angle, and then tilts up as it approaches completely closed, and remains parked in that position. This puts the upper portion of the slide-out, and the upper slide-out wall framing, under severe load when traveling. The weight of the cabinetry/counter tops/appliances are cantilevered, pulling the top of the slide-out toward the wall opening as it bounces during travel.

Solution: Bring the slide-out in level over ultra-high-molecular-weight polyethylene (UHMW), or a similar material, used as glide bars under the kitchen slide-out. These are placed on the floor prior to closing the kitchen slide-out. The glide bars eliminate the severe dip as the slide-out comes in, and are left in place to minimize bounce, while pulling the trailer, by supporting some of the weight of the slide-out.

Construction: The glide bars need to be as long as the slide-out depth, and they need to be tapered. To determine the taper, bring the slide-out in an inch or two. Measure the height from the floor to the bottom of the slide-out at four locations along the full length of the slide-out (at the end of the slide-out toward the rear, just before the sink cabinet makes the “L” turn, and two equally spaced locations in the middle). Write down these measurements for each of the four glide bar positions.

Next bring the slide-out in as far as it will go (as if you are ready for travel). Take height measurements at the same four locations, along the full length of the slide-out, as you did when it was in an inch or two. Now add $\frac{1}{2}$ ” to these height measurements. However, when using the glide bars, make sure that the top of the slide-out does not pull away from the outside of the wall when the slide-out is fully closed, and the hydraulic rams have drawn the bottom in tight. With the glide bars in place, they will support some of the weight of the kitchen slide-out, thereby offloading some of the force at the top of the slide-out. (NOTE: You may want to experiment with the taper using some inexpensive material first to determine how much to add to the measurements you took when the slide-out was fully closed. I used plastic coated 2”x 2”s purchased at Lowe’s.) For carpeted areas, the carpet and pad will compress, where the glide bar(s) is(are) located, under the weight of the slide-out. In anticipation of this, for any glide bar(s) located on carpet, add some additional height to the height you use for glide bars on the tiled floor. You are on your own here because everyone has different carpet and pad. I increased the $\frac{1}{2}$ ” additive I used for the glide bars on the tiled floor to $\frac{7}{8}$ ” for the glide bars on the carpeted floor.

Material: I bought two 12”x 12” pieces of UHMW from Professional Plastics (professionalplastics.com). One piece at 1½” thick (\$48), and one piece at 2” thick (\$65). As you can see it is very expensive. If you opt to buy longer material the price goes up exponentially. My slide-out is 24” deep, so I used my circular saw to cut the eight pieces required (four 12”x 1½”x 2” and four 12”x 2”x 2”), and the correct taper, and then joined them together with U-bolts to achieve the overall length needed (see photo). You can cut the glide bar piece three inches wide if you do not want to have any of the UHMW material left over. Diagram 1 shows the method I used to end up with the correct taper.

Tapered Glide Bars



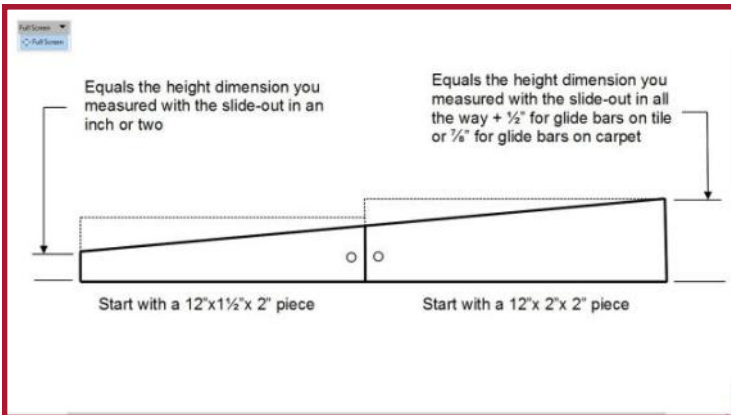
To obtain the correct taper on the two halves of the glide bars, butt the two pieces together, on their sides, as shown below. Mark the left end of the 1½" piece using the height you measured with the slide-out in an inch or two. Mark the right end of the 2" piece using the height you measured when the slide-out was in all the way plus the proper additive (½" for a glide bar on tile or ⅞" for a glide bar on carpet). Using a straight-edge, draw a straight line between the two marks, cut along that line to produce the correct taper. (The dashed lines are shown to depict the material before the slide is cut, and the circles are shown to depict where you will drill holes for installing the U-bolt.)

Remember to chamfer the glide bar surface edges so they don't catch on the bottom of cabinetry or the slide-out. To do this, I used a block plane. In tiled areas, the glide bars have a tendency to move out of



place as the slide-out begins to ride up onto them as you close it. To overcome this we place a piece of non-slip shelf-liner on the tiled floor under the glide bars. The liner material I used is a tacky, spongy material. If the glide bars continue to move, use your foot to hold them in place until the slide-out transfers enough weight onto them to prevent movement.

General use: It takes about a minute more to use the glide bars than if we did not use them. When we are parked (usually for a month or more at a time) we fold the glide bars at the U-bolt connection and store them inside on the tops of the slide-outs. We have about 10,000 miles of use with this system. It works for us and only cost about \$100.

Other slide-out seal problems: We have had other seals tear at the upper corners. After replacing the seals I installed a piece of the UHMW cut to a suitable length, width and thickness. It is essentially a filler that the slide-out can push against when closed, and rub against during travel so as not to tear the seal. I installed the UHMW stops at the top, exterior corners with pop rivets (See photo). Mine are white since I used scrap material from the kitchen slide-out glide bar project. You may not like that look. The material may come in other, more desirable colors.

Regarding seal replacement: If you do it, or you hire someone to do it, be sure you, or they, caulk the edge of the seal to the frame. This will prevent water from seeping in behind the seal and rusting the metal teeth that clamp it to the frame lip. Also, since two different seals are used on the dinette/living room slide-out, be sure the upper corners of the newly installed seals are sealed with caulk. This will prevent water from getting inside the seals and rusting the metal teeth. I use 100% silicone. Marine grade is best, but the Lowe's brands will do.

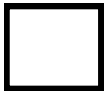
