### CONDITIONS OF THIS AGREEMENT

Hall usage includes the following:

- (1) The use of <u>TWENTY 8 FT. TABLES</u> and <u>110 CHAIRS</u> as needed.
- (2) Use of stove for <u>HEATING PREPARED FOOD ONLY</u>. No cooking allowed.
- (3) Use of refrigerator.
- (4) Hall <u>PREPARATION TIME</u> for decorating is limited to a total of <u>TWO (2) HOURS</u>. This time is not part of the usage time. <u>THURSDAY</u>, <u>FRIDAY EVENING</u>, OR <u>SATURDAY AM</u>, <u>NOT</u> to exceed the two hours and be completed by 10:00 PM will be negotiated with the user.
- (5) Hall will be available <u>ONE (1) HOUR PRIOR</u> to the actual event for DJ, BAND, FINAL DECORATIONS (e.g. balloon set up) and CATERER.
- (6) Vacating of premises will be completed within **45 minutes** after designated time of party.
- (7) Failure to abide by rules will result in forfeiture of security deposit.
- (8) Decorations CANNOT be put on walls or hung from the mirrored ceiling area.
- (9) Decorations and streamers can be hung from the ceiling with the hooks we supply. No tacks or tape on ceiling. Confetti is not permitted.
