Legislative Update

Things Are Heating Up in Raleigh

LEGISLATIVE UPDATE 4/06/03

It's been a very busy few months in Raleigh this session because we've got a lot on our plates this year. Because of this, I have had to focus primarily on issues that we are addressing at the state level. While there are many other issues on the national level, and they need to be pursued, I will leave those to our MRF and NCOM reps. to fill you in on. In this report, I will try to bring you up to date on the three bills we are working on in our organization.

HB-54/SB-32

May is Motorcycle Awareness Month

The week after opening day, I was in Raleigh to begin meeting with the legislators to inform them on the issues that we were concerned with. I stopped by Sen. Stan Bingham's office because he was supportive of our helmet bill last session, and to my knowledge, is the only one on the senate side who rides. I was trying to find a supporter to introduce companion bills in the senate. I mentioned to him that my Representative, Dewey Hill, was going to introduce a joint resolution to make May Motorcycle Awareness month every year, and that we wanted to use that as a building block for a public awareness media campaign. Evidently, he liked the idea so much that he ignored the part about it already being in the works. He decided, on his own, to introduce a bill doing just that in the senate. Unfortunately, by doing so he shot us in the foot. Not only did that bill circumvent the joint resolution, the wording in his bill was atrocious. There was a line in the wording (Whereas, due to the hazards created by motorcycling...) that made it appear that we are the problem, not the other drivers.

I immediately went to Rep. Hill to let him know that we were not trying to go around him, or to speed up the process, but that Sen. Bingham had jumped the gun and done this on his own. He said that it was not a problem, he would introduce a companion bill with better wording, and the only thing it would do is slow down the process. I then went to Bingham to ask him about the wording problem. He agreed that the wording was a problem. He had used the wording from another state's proclamation, and had not picked up on that line. He is going to amend the wording in committee to match the wording in HB-54, so if you want to view the bill text on the General Assembly's website pull up HB-54. That is what the finished product will look like.

Both bills were assigned to Rules and Operations in their respective bodies. Rep. Culpepper is chair of that committee in the House, and Sen. Rand in the Senate. I am working with both now to get the bills on the committee calendars. While the situation with Bingham complicated things, please do not gripe at him as he was only trying to help, and we will definitely need him later. I only brought this up to explain why what should have been a simple matter is taking so long. This bill should be a no-brainer and sail right through, but it wouldn't hurt to contact the members of the committees to let them know we are involved and we all want this.

HB-670 Motorcycle Safety Act

Our helmet bill went in this session with 4 primary sponsors and 21 co-sponsors. This means we are already coming out of the gate with support from

20% of the house. It was assigned to Judiciary-III and then Finance. As you all know, this is going to be a tough one and will require a lot of work on our parts. I am very optimistic about this year though. I don't know why, but there seems to be a very different atmosphere in the legislature this year. We are being received very differently, and taken more seriously. It may be that there are 39 new legislators. It may be that we are pursuing much more than just the helmet bill. We also have at least three Harley ridin' reps. in the House, who are drawing a lot of attention. We also hit the ground running very hard, very early in the session. I imagine it's a combination of all of these things, and some we'll never know about.

Reps. John Sauls, Keith Williams, and Arthur Williams were three of the primary sponsors of our bill. (Dewey Hill was the fourth) Sauls and Keith Williams were both determined to pass this bill from the day they got there. Arthur Williams is a different story. Several years ago, he was on the Kyle Petty Charity Run and was involved in an accident. He swears that a helmet saved his life, and will be happy to tell you the story over and over again. Kyle Petty even flew with him in the Med-Evac helicopter to the hospital. When I first spoke to him, he told me there was no way he could ever see his way clear to support our bill. However, after hearing from many of us and some pressure from Sauls and the other Williams, he has gone from being dead set against us to being a primary sponsor. I consider this to be a major coup for our side. If we can win this guy over, we have a chance with any of them. He said he was forced to weigh his own convictions against the wishes of his constituents, and apparently he made the right choice. That is how it is supposed to work in the legislature, but it is rare that it actually goes that way. You have to respect him for that.

I am working with Keith Williams to get the bill on J3's calendar as quickly as possible. We hope to get it heard there as soon as we can to give the opposition less time to gear up against us. Rep. Sutton is chair of J3. The members of this committee are where we really need to focus our lobbying efforts right now. Then it's on to Finance. It wouldn't hurt to start in on the members of that one as well. You can find out who is on these committees through the General Assembly's website.

HB965 / Right-of-Way Violations Bill

This one has been a tough one folks. When I originally approached Dewey Hill about this issue, he told me that he would be happy to introduce the bill, and did not see who would be opposed to it. It did not take long to find out. As soon as he started talking it around to drum up support, the lawyers started squealing. The purpose of this bill is to increase the penalties and close the trapdoor a lot of the lawyers use. Failure to yield carries a \$25.00 fine and is basically a slap on the wrist. Unfortunately, even when a motorist is charged with a more serious offense, the lawyers plea-bargain it down to failure to yield. That is exactly what we are trying to stop and they don't like it. It makes it hard for them to look like saviors to their clients. I even had a District Court Judge on opening day tell me that we needed to drop the bill and pursue the issue through the Association of District Attorneys. Yeah right. The judges and District

Attorneys are the ones accepting the plea bargains in the first place! Let the foxes guard the henhouse? Uh-uh.

The lawyers didn't bother Rep. Hill that much. (He feels pretty much the same way I do about them) As he continued putting out feelers though, he started getting feedback from a faction in Raleigh that equate fines and penalties with "new taxes". There are also those who hold driving privileges sacred, and this bill would come with a mandatory revocation of license for 30-90 days upon conviction.

Several times to date he has had second thoughts about the bill and I have had to blitzkrieg him with statistics, copies of bills that other states are introducing, and I've even had to bring potential co-sponsors to his door. What finally clinched it for him though, is when I brought him two freshman Democrats, one of whom is a lawyer, willing to sign on. He told me last Wednesday, that he was finally sending something to drafting. Good thing too, since that was the deadline in the House. As of this writing, I don't know what wording he submitted. He told me he was trying to craft a bill that stood a chance of passing, but still had teeth in it. When I get a copy of the draft, I will get the information out to you. In the mean time I urge all of you to contact your own representatives to let them know how we feel about this issue as well as the two bills we have in. The more of us they hear from, the more power we have!

I want to say thank you to Mike Hodges and Peggy Burns for being in Raleigh at times that I was unable to get there. I have not put out a hue and cry for the membership to go, because I realize that you all work and your time is limited. Your few available days off would probably be better spent on days that we have something specific going on. If you do have time to get there though, by all means visit your reps. and ask for their support. If they don't hear from you, they can't possibly know what you want. Thanks also to Vinny Neuman for his well timed updates. I have a hard time doing what needs to be done and keeping everyone informed at the same time. And thanks to each and every one of you who has taken time to go to Raleigh, write, or email your reps. And as you may have noticed, my own representative, Dewey Hill, is or will be a primary sponsor on every piece of legislature we have in this year. I think that deserves a very special thank you from each and every one of us.

Vinny's Report from Raleigh

Below is an excellent report and information from Vinny Neumann of Chatham Co. CBA/ABATE of NC. Please read; and I would like to add a couple comments.

You will note that the changes to the existing law are underlined. Thanks goes to Tim Duncan of SCRC for pointing out to me today the weird verbage under Section 3., (12). It appears that your registration bill would go up with luggage racks, trailer hitches, saddle bags, etc. We questioned Mike Hodges about this as he has a bit of knowledge about the existing law and it turns out that this is the same as the law already is,... the only change is that we have allowed an additional 3 bucks per bike to beef up the rider training program in our state. (If I have this wrong, Sam please correct me).

Today there were four members of the Randolph Co. Chapter in attendance, two from Raleigh Chapter, one from Charlotte Chapter, one from Chatham Chapter, one from Brunswick Chapter, one from High Point Chapter, and one member of the Greater Raleigh Chapter of Southern Cruisers Riding Club. Sitting with us was Mike Causey, professional lobbyist - friend to bikers - past candidate for public office.

The tide has changed this year, I'm still not exactly sure why but I'll take it! I had the opportunity to talk with Rex Baker after House session and he is optimistic about our chances this year. While it is sort of odd not having him as a bill sponsor, he is confident we will do well. He has been appointed a chairmanship of a very busy committee this year and will not have the time to shop a bill like ours this go-round and it is time to let the freshmen get their feet wet. Be that as it may, there are some strong, well entrenched co sponsors of this bill. In fact, with 25 sponsors (including the primary sponsors) it puts us at introduction with a little over 20% of the House.

It would be a good thing to write Sauls, A. Williams, K.Williams, and Dewey Hill and thank them for entering this bill! Not only that, but Speaker Richard Morgan assigned it to Judiciary III committee, if favorable, Finance. Blust is a sponsor and is on the Judiciary III committee, Connie Wilson is on the JIII committee and supported our bill in the past.

I will check to see if any of the other committee members supported us in the past.

Dear Fellow Motorist,

I wonder if you realize how close you came to injuring or killing me today. You seemed completely unaware that you began to move into my lane when only half of your car had passed me. If I had glanced at my mirror at that second, I probably wouldn't have been able to brake fast enough to keep you from hitting my front tire and throwing my off my motorcycle. I apologize for slapping your window and lecturing you. It probably seemed to you that some crazy biker was

trying to terrorize you. I'm sure you're a nice lady and wouldn't want to hurt anybody, but your inattention nearly caused a collision that would have been a mere fender bender for your Mercedes Benz, but could have caused me to be killed, and that made me angry.

Perhaps you are not completely to blame. As cars get smoother, more comfortable and easier to drive, as they get quieter inside and come equipped with high-power, nine-speaker, surround sound stereo's, as more distractions like cell phones and laptop computers become available for you to use while driving, it's easy to forget that you are hurling two tons of steel and plastic down the road. Inside that nice new car of yours, you have air bags, seat belts and anti-lock brakes to keep you safe and since obviously have at least the minimum required insurance, a collision with a 600 pound motorcycle just isn't very threatening to you, but it's life and death for me.

I ride a motorcycle nearly every day, year round, because I love the feeling of being in the open air, feeling the temperature changes and the bugs splatter on me, and of course the sunshine and wind on my face. I love the feel of leaning to steer and accelerating out of a curve. I love it so much that I not only ride to work everyday, I ride for fun on the weekends. My idea

of a fun vacation is riding my motorcycle to a rally in Arizona or Florida or even Texas. I'm very aware of the dangers and I have decided that, to me, the risk is an acceptable trade off.

And you must understand that regardless of how you feel about motorcycles, they are legal vehicles and are permitted to use the roadways. Regardless of your feelings about "bikers", I am a human being and deserve the same consideration that you wish to receive from others. And if you accidentally kill me because you weren't paying attention or didn't see me, you will have to live with the fact that you caused another human being to die. I can't believe you would want that to happen, so let me try to help you understand what I must do to minimize the danger of riding and how you can help me stay out from under your wheels and not come crashing through your windshield to die in your front seat.

First, you have to understand that the natural at-rest position of a motorcycle is on its side. In order to keep it upright, I have to balance it. When I get it up to 35mph or so, natural forces help me to keep it upright, that is as long as the surface I'm riding on remains pretty consistent. But on those patched roadways, or worse yet those under

Cont. from Page 6 construction, there are lots of hazards that can upset that natural balance. Raised surfaces, such as the edge of a patch that your car bumps over easily can drop a motorcycle in a second if not crossed over properly. Loose surface gravel and curves that are sloped in the wrong direction all pose potential hazards if I don't ride carefully and give myself enough space to react. I swear sometimes it seems like the highway department is trying to do me in. But I hope that they, like you, just don't understand that the dynamics of a motorcycle is different than that of a four-wheeled vehicle. With practice and concentration, I've learned how to keep the shiny side of the motorcycle facing up, as long as you grant me a few courtesies.

If I leave slightly more than a car length between me and the vehicle I'm following, it's so I have enough time to react to the piece of truck tire that's lying in the roadway. It's not an invitation for you to slip into the space while you're trying to leapfrog through heavy traffic. That forces me to drop back and open another gap that someone else will leapfrog into. And since I don't tailgate you, extend the same courtesy to me. If you need to look down to change the tempera-

ture on your climate control, you need to have enough time to avoid hitting me if the traffic suddenly slows. When you see a small gap in the middle of a group of motorcycles, don't maneuver quickly into the gap. It's common for motorcycles to travel in groups... it's part of the fun. Needlessly splitting up the group is rude and dangerous.

These are common courtesies and safe driving practices for all vehicles and are particularly important to me as a motorcyclist. But in order for you to extend me these courtesies you have to be aware of my presence. I know that a motorcycle can easily hide in a blind spot so when I ride behind you in an adjacent lane, I always try to ride so I can see you in your rear view mirror. That means that you can see me if you scan your mirrors regularly as they teach you in any safe-driving class. I always ride with my headlamp on to make more visible. My last line of defense is a rather loud exhaust system. You may find that annoying, but if it makes you notice that I'm traveling in a blind spot beside you, I consider it a safety device. I try not to annoy my neighbors with the noise, but I use it on the highway.

Some motorcyclists ride aggressively and

faster than the flow of traffic. Passing other vehicles can be safer than being passed by them in some situations. Maybe the biker that roars past you is just a sociopathic punk, or maybe he's trying to observe how you're driving and control the time that you are actually close enough to hit him. In either case, what can you gain by getting mad and returning the aggression? Notice me, but please don't stare at me as you drive beside me. Remember that you tend to steer in the direction that you are looking. Let me have my lane.

You and I can share the road safely as long as you give your driving the attention it deserves and give me the same considerations that you would want from others. In return, I'll try not to vent my anger at you when another less considerate driver does something that endangers me. And when we get to where we're going I can take a smaller parking spot designated for motorcycles and leave the big space for your luxury automobile.

Why We Ride Enjoy Every Minute of the Ride

There is cold, and there is cold on a motorcycle. Cold on a motorcycle is like being beaten with cold hammers while being kicked with cold boots, a bone bruising cold. The wind's big hands squeeze the heat out of my body and whisk it away; caught in a cold October rain, the drops don't even feel like water. They feel like shards of bone fallen from the skies of Hell to pock my face. I expect to arrive with my cheeks and forehead streaked with blood, but that's just an illusion, just the misery of nerves not designed for highway speeds.

Despite this, it's hard to give up my motorcycle in the fall and I rush to get it on the road again in the spring; lapses of sanity like this are common among motorcyclists. When you let a motorcycle into your life you're changed forever. The letters "MC" are stamped on your driver's license right next to your sex and height as if "motorcycle" was just another of your physical characteristics, or maybe a mental condition. But when warm weather finally does come around all those cold snaps and rainstorms are paid in full because a motorcycle summer is worth any price.

A motorcycle is not just a two-wheeled car; the difference between driving a car and climbing onto a motorcycle is the difference between watching TV and actually living your life. We spend all our time sealed in boxes and cars are just the rolling boxes that shuffle us languidly from home-box to work-box to store-box and back, the whole time entombed in stale air, temperature regulated, sound insulated, and smelling of carpets.

On a motorcycle I know I'm alive. When I ride, even the familiar seems strange and glorious. The air has weight and substance as I push through it and its touch is as intimate as water to a swimmer. I feel the cool wells of air that pool under trees and the warm spokes of sunlight that fall through them. I can see everything in a sweeping 360 degrees, up, down and around, wider than PanaVision and higher than IMAX and unrestricted by ceiling or dashboard. Sometimes I

even hear music. It's like hearing phantom telephones in the shower or false doorbells when vacuuming; the pattern-loving brain, seeking signals in the noise, raises acoustic ghosts out of the wind's roar. But on a motorcycle I hear whole songs: rock 'n roll, dark orchestras, women's voices, all hidden in the air and released by speed.

At 30 miles an hour and up, smells become uncannily vivid. All the individual tree-smells and flower-smells and grass-smells flit by like chemical notes in a great plant symphony. Sometimes the smells evoke memories so strongly that it's as though the past hangs invisible in the air around me, wanting only the most casual of rumbling time machines to unlock it. A ride on a summer afternoon can border on the rapturous. The sheer volume and variety of stimuli is like a bath for my nervous system, an electrical massage for my brain, a systems check for my soul. It tears smiles out of me: a minute ago I was dour, depressed, apathetic, numb, but now, on two wheels, big, ragged, windy smiles flap against the side of my face, billowing out of me like air from a decompressing plane.

Transportation is only a secondary function. A motorcycle is a joy machine. It's a machine of wonders, a metal bird, a motorized prosthetic. It's light and dark and shiny and dirty and warm and cold lapping over each other; it's a conduit of grace, it's a catalyst for bonding the gritty and the holy. I still think of myself as a motorcycle amateur, but by now I've had a handful of bikes over a half dozen years and slept under my share of bridges. I wouldn't trade one second of either the good times or the misery. Learning to ride was one of the best things I've done.

Cars lie to us and tell us we're safe, powerful, and in control. The air-conditioning fans murmur empty assurances and whisper, "Sleep, sleep." Motorcycles tell us a more useful truth: we are small and exposed, and probably moving too fast for our own good, but that's no reason not to enjoy every minute of the ride.

A Message From "Aid to Injured Motorcyclists" (AIM)

WHAT SHOULD I DO IF I GO DOWN?

The most serious problem bikers have to deal with is the inevitable traffic accident. Approximately 70% of all multi-vehicle accidents involving a motorcycle are not the motorcyclist's fault.

The following will help you protect your rights and answer the question: What should I do if I go down?

INFORMATION TO GET IMMEDIATELY:

1. **Witnesses:** This is listed first for they will disappear the fastest (especially due to the public's fear of bikers). Try and get some sort of identification so they might be contacted later, i.e., name, address, phone number, license plate number, where they work, etc.

2. **Other Driver:** All traditional information is needed: Name, address, phone number (at home and work), driver's license, make/model/color and license of the vehicle. In addition, a very helpful piece of information is the insurance carrier of the driver of the car. If this is not obtained and if the other driver does not respond to letters sent by your attorney, you will find that most states require long waiting periods before supplying the necessary information to pursue your case - that means recovery for your injury could be delayed.

One final thing. Listen to and memorize statements made by the other driver. These statements (also known as admissions) may be used as evidence in many jurisdictions. An example of this would be the driver of the left turning car saying, "I didn't see you". His statement could be used to prove the accident was his fault. **NOTE:** Remember, this also works in reverse. Anything you say can also be used against you.

POLICE REPORT Although most of what is recorded in a police report cannot be used in court, it is a great negotiating tool. Keep in mind that most personal injury cases are settled rather than go to trial. A

favorable police report can be instrumental in bringing you a quick and generous recovery for your injuries. As we all know, cops can be a mixed bag. However, (in an accident situation) I have found most police to be fair in their assessment of fault. This is especially true of the motorcycle cop.

INJURIES This is not the time to show how macho you are. After the actual collision, take a few minutes to check yourself out. The initial shock may numb you as to how injured you really are. Remember, the human body is not made to be bounced off the ground. It is a good idea (and will aid in showing the validity of your case) to get checked out at the local emergency room (hospital) or by your own doctor. Be sure to explain all your pains to the doctor so he or she can make a complete evaluation and treat you appropriately for the injuries.

NO STATEMENTS When you are contacted by the insurance company, (which is usually immediately - even right at your hospital bed) tell the adjuster you don't wish to give a statement at that time. Even if your statement seems favorable to you, the insurance company would have lots of time to pick out the flaws. Keep in mind that the adjuster's job is to save the insurance company money and, therefore, any money offered as a "fair settlement" will usually only be fair to the insurance company.

CALL A PERSONAL INJURY ATTORNEY The first 24 hours after an accident are crucial for your case. An immediate investigation should be started including photographs showing your injuries, the accident scene and the involved vehicles.

Statements from witnesses and the other driver should be gotten as soon as possible. The police report should be requested and an inspection of the point of impact for skid marks and other material evidence should be made. You will notice that I advised you to call an attorney who specializes in personal injury. The law, as with medicine, is highly specialized,

and you are entitled to be represented by an attorney who is best qualified to obtain a maximum recovery for your damages. A quick call to the attorney entitles you to the following services:

- 1) Protection from insurance company employees - the magic words are: "I am represented by counsel and don't wish to make a statement."
- 2) A "house call" if you are unable to go to the office.
- 3) Immediate investigation of your claim.
- 4) The possibility that your bike will be fixed prior to the settlement of your injuries and a rented vehicle while you wait.
- 5) The evaluation and protection of your legal rights.

A BILL TO BE ENTITLED AN ACT TO MODIFY THE REQUIREMENT FOR THE USE OF HELMETS BY OPERATORS AND PASSENGERS ON MOTORCYCLES AND TO ADJUST THE FEE ON PRIVATE MOTORCYCLE REGISTRATIONS IN ORDER TO PROVIDE ADDITIONAL FUNDS FOR THE MOTORCYCLE SAFETY PROGRAM.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-140.4(a) reads as rewritten:

"(a) No person shall operate a motorcycle or moped upon a highway or public vehicular area:

- (1) When the number of persons upon such on a motorcycle or moped, including the operator, shall exceed exceeds the number of persons which that it was designed to carry.
- (2) Unless the operator and all passengers there on wear safety helmets of a type approved by the Commissioner of Motor Vehicles. Vehicles, except that:
 - a. If the operator is 21 years of age or older and has had a motorcycle license or a motorcycle endorsement for more than 12 months, then the operator may operate the motorcycle without a helmet.
 - b. If the operator is allowed to operate a motorcycle without a helmet, pursuant to sub-subdivision a. of this subdivision and the passenger is 21 years of age or older, then

the passenger may ride without a helmet."

SECTION 2. G.S. 20-87(6) is repealed.

SECTION 3. G.S. 20-87 is amended by adding a new subdivision to read:

"§ 20-87. Passenger vehicle registration fees.

These shall be paid to the Division annually, as of the first day of January, for the registration and licensing of passenger vehicles, fees according to the following classifications and schedules:

- (12) Private Motorcycles. - The fee on private passenger motorcycles shall be fourteen dollars (\$14.00). When a motorcycle is equipped with an additional form of device designed to transport persons or property, the fee shall be twenty-one dollars (\$21.00). Five dollars (\$5.00) of the fees collected pursuant to this subdivision shall be used, in addition to any other funds appropriated for this purpose, to fund the Motorcycle Safety Instruction Program established pursuant to G.S. 115D-72."

SECTION 4. This act becomes effective October 1, 2003.

A BILL TO BE ENTITLED AN ACT DESIGNATING

MAY OF EACH YEAR AS MOTORCYCLE AWARENESS MONTH.

Whereas, motorcycle riding is a popular form of recreation and transportation for thousands of people across the State and nation; and

Whereas, the safety of motorcycle riders should be of great concern to all motor vehicle operators; and

Whereas, it is especially important that the citizens of our State be aware of motorcycles on the streets and highways and recognize the importance of motorcycle safety; and

Whereas, all motorcycle organizations, clubs, dealerships, groups, and highway safety officials should

join in actively promoting safe operations, increased rider training, improved licensing efforts, and motorist awareness; and

Whereas, during May, all highway users should unite in the safe sharing of roadways throughout the State of North Carolina; Now, therefore, The General Assembly of North Carolina enacts:

SECTION 1. Chapter 103 of the General Statutes is amended by adding a new section to read: "103-11. Motorcycle Awareness Month.

The month of May of each year is designated as Motorcycle Awareness Month in North Carolina."

SECTION 2. This act is effective when it becomes law.

HB965: Right-of-Way Violation Bill

GENERAL ASSEMBLY OF NORTH CAROLINA
SESSION 2003
HOUSE BILL 965

Short Title: Failure to Yield Causing Death or Injuries
(Public)

Sponsors: Representatives Hill; Church and Pate.
Referred to: Judiciary III. April 9, 2003

A BILL TO BE ENTITLED AN ACT TO PROVIDE
PENALTIES FOR PERSONS WHO CAUSE INJURY
OR DEATH WHEN FAILING TO YIELD THE RIGHT-
OF-WAY UNDER CERTAIN CIRCUMSTANCES.

The General Assembly of North Carolina enacts:

SECTION 1. Chapter 20 of the General Statutes is amended by adding a new section to read: "§ 20-160.1. Failure to yield causing injury or death; penalties.

Notwithstanding any other provision of law, a person convicted of failure to yield while approaching or entering an intersection, turning left at a stop or yield sign, entering a roadway, upon the approach of an emergency vehicle, or at highway construction or maintenance shall be punished in the following manner, in addition to any other punishment:

(1) When there is no great bodily injury or death resulting from the violation, the violator shall be fined two hundred dollars (\$200.00) and the violator's

drivers license or commercial drivers license shall be suspended for 30 days.

(2) When there is great bodily injury but no death resulting from the violation, the violator shall be fined five hundred dollars (\$500.00) and the violator's drivers license or commercial drivers license shall be suspended for 90 days.

(3) When a death results from the violation, the violator shall be fined one thousand dollars (\$1,000) and the violator's drivers license or commercial drivers license shall be suspended for six months."

SECTION 2. This act becomes effective December 1, 2003, and applies to offenses committed on or after that date.
