Persons in Respect of Whom Child Benefit is Payable Council Tax Guidance Notes

This discount is mainly for the benefit of single parents whose child turns 18 and is counted for Council Tax purposes.

What criteria is needed to qualify for this discount?

The person must be:

a)Over 18 years b) The liable person receives Child Benefit for that person.

What reduction will I receive?

If there are two or more adults and another person within the household turns 18 but Child Benefit is still in payment for that 18 year old there is no discount.

If there is one adult and another person within the household turns 18 but Child Benefit is still in payment for that 18 year old there is a 25% discount.

If a person within the household turns 18 but Child Benefit is still in payment for that 18 year old lives alone or lives in the property along with other students or school leavers an application under this criteria is not applicable. However if the person is in full time education they may apply for a student discount. If they have recently completed a full time education course or a qualifying course and they are under 20 years old then they may apply for a school or college leaver discount. In both of these cases an exemption can be granted.

Who should complete the application form?

The person named on the bill.

What additional information do I need to supply with my application form? None.

What should I do about paying my Council Tax in the meantime?

The bills previously issued must be regarded as correct and due for payment as requested.

What should I do if the payment of Child Benefit comes to an end?

Notify the Council within 21 days of the change occurring.

When will my discount start?

It will start from the date the person for whom another person is entitled to Child Benefit becomes 18.
