What's Happening At The Board of Selectmen

(Editor's note: the following are edited summaries of Board minutes, which are available in full and unedited on the Town web site at www.weststockbridge-ma.gov and at the Town offices.)

September 15, 2008

Open Meeting. Present: Selectmen Tina Skorput Cooper, Chair; Curt Wilton. Not present: Michael Kirchner. Also present: Administrative Assistant Mark Webber.

Police Appointment. Tina Skorput Cooper withdrew her vote to appoint Gary Mitchell as a part-time police officer at the last meeting pending an opinion from Town Counsel on Mr. Mitchell's retirement status from the Springfield Police Dept. The matter will be taken up again at next week's meeting.

Public Hearing. The Public Hearing for the West Stockbridge Sportsmen's Club Change of Manager Request was re-opened. Club president Vincent Stannard presented an application naming Dion Hall as Manager. There being no comment on the application from those present, the application was approved.

Fire Station Painting. Regarding the planned painting of the Fire Station, Fire Chief Peter Skorput said that Department personnel could paint the lower front side of the building but that the remaining three sides would require scaffolding and others to do the painting. The Board agreed to put in a request to the Berkshire County Sheriff's Department Community Service Program. Two persons in the audience also volunteered.

Library Deliveries. Paula Farrell asked if the Inter-Library Loan truck could use the service lane on the west side of the Town Offices building to deliver and pick up books. Curt Wilton and Peter Skorput questioned whether the narrow paved lane could accommodate the truck. Paula will find out the gross vehicle weight of the truck, and the matter will be discussed at a later meeting.

Transfer Station Cam. Administrative Assistant Mark Webber presented a quote for \$1,300 for the installation of a security camera and monitor at the Transfer Station. Station attendant Bill Pixley is

concerned that people are co-mingling other items with paper in the paper bin, which cannot be seen from inside the attendant's shack. Webber added that there is a leak in the roof over the paper bin that should be repaired because wet paper costs more to transport to the recycling facility. Curt Wilton suggested that the Town's custodian, Peter Skorput, be asked to repair the roof and added, 'It's a sad day in West Stockbridge when we are asked to spend \$1,300 on a camera to monitor the paper bin." The Board will ask Bill Pixley to a Selectmen's meeting to discuss Transfer Station operations.

Other business:

- Mark Webber will attend a public procurement seminar in Boston the first week of October.
- Building Inspector Don Fitzgerald will be asked to attend the next Board meeting to discuss his proposal to adjust building permit fees.
- Highway Department will remove and dispose of old unused wrestling mats in the gymnasium.
- Mark Webber will work with Tree Warden Jim Hallock to prepare a Tree Warden job description.
- COA van will be returned from the dealer this week fully operational and ready to ride.

September 22, 2008


Open Meeting. Present: Tina Skorput Cooper, Chair; Curt Wilton, Michael Kirchner. Also present: Administrative Assistant Mark Webber.

COA Drivers. In response to a request from the Council on Aging, the Board will place an ad in the Shopper's Guide and a notice in the next Local Yokel.

Old Town Hall. After a final review of the Request for Proposals (RFPs) for the future use and/or re-use of the Old Town Hall, the Board instructed Administrative Assistant Mark Webber to publish the legal notice in both the Berkshire Eagle and Goods and Services. The RFP will also be available on line. Meanwhile, the Board will discuss winterizing the building with Peter Skorput and the Building Inspector.

Skate Park. The Town's insurance carrier will be asked to review the skate park under construction at

Jim Hallock and Jenni Roy Hallock of JLH Outdoor Services are active town residents as well as local business owners. Jim, a Berkshire native, began his working life in the car repair business. For many years he was a Blue Level Master Ford Technician, the top diagnostic person for Ford cars in Berkshire County. After 14 years he developed an allergy to petroleum and needed to find another line of work. With a small loan he bought used equipment, re-built the motor, then went to

work on a 100 acre in property in Sandisfield. As his client list grew, so did his equipment inventory (which today is very impressive) and he now has a large landscape and tree service company providing a wide variety of services.

Jenni is third generation West Stockbridge. Prior to creating JLH with Jim she worked with her parents, Joe and Anne Roy, owners of The Floor Store. Jenni and Jim have been married for two years and between them have four children: Shannon, 9; Mary, 8; Caitlyn, 7; and James, Jr., 6. Another girl, Abby, is on the way, expected in January. Between running the business and taking care of a large family, they still manage to find time to volunteer for a lot of community activities. Jim was recently elected Tree Warden for the Town of West Stockbridge; is a volunteer Fireman and EMT (he began as a volunteer in the Monterey Fire Department at age 13!); a member of the Southern Berkshire Ambulance Squad; a Cub

Scout den leader and a den assistant for another Cub Scout troop. Jenni is President of the Muddy Brook PTA; a member of the Zucchini Festival Committee for which she manages several projects; a very active member of the West Stockbridge Parks & Recreation Committee; and a volunteer for many activities at Muddy Brook.

Both Jenni and Jim are very proud of the way they run their business. They say what really counts is reliability, being on time, giving accurate estimates with fair prices, quick responses to urgent problems, cleaning up the job site and last, but definitely not least, being fully insured including workers' comp. 

the Village School. The Town already has insurance coverage for the facility, which is being updated.

Tree Work. Maple Street resident Dan Howard asked permission to remove a dying tree adjacent to his property, which he is concerned will come down and damage his shed. Tree Warden Jim Hallock and Building Inspector Don Fitzgerald determined the tree is on Orchard Street, a so-called "paper road." Tree Warden Hallock has no objection to removal of the tree as long as Mr. Howard signs a release and employs a certified arborist. Mr. Howard agreed and signed the release.

Road Work Bids. Bids were opened for three road paving and reclamation projects. Three bids were received for "Full Depth Reclamation, High Street" with All States Asphalt the apparent low bidder. Five bids were received for "Bituminous Paving, High Street" with Palmer Paving the apparent low bidder. Five bids were also received for "Bituminous Paving, Swamp Road" with Palmer Paving again being apparent low bidder. The bids were closed and taken under advisement. Curt Wilton will review the bids for accuracy and eligibility and make a recommendation to the Board at their next meeting.

Building Permit Fee Schedule. The Board approved a revised Building Permit Fee Schedule proposed by Building Inspector Don Fitzgerald. The new fee schedule will take effect immediately and bring our fees closer in line with neighboring towns.

Police Appointment. Tina Skorput Cooper asked the Board to review the appointment of Police Officer Gary Mitchell, which had been voted on by the Board two weeks earlier. Skorput Cooper noted the Board had requested, but had not yet received, an opinion from Town Counsel on the legality of hiring Mr. Mitchell. TSC wanted to stay the appointment until the Board has received the legal opinion.

Mike Kirchner expressed concern about discussing personnel matters in open meeting, and said that proper executive session procedures need to be followed. Gary Mitchell was in attendance and waived his executive session privilege, stating that his disability retirement from the Springfield Police Department was common knowledge when he worked for the Town of West Stockbridge several years ago.

Chief Stanton protested that his recommendations for appointment are being opened to political scrutiny. Mr. Mitchell asserted that he was released five years ago due to a "witch-hunt." Richard Klein, Selectman at the time of Mitchell's dismissal, responded that he was let go as a result of an opinion from Town Counsel, not a witch hunt.

A motion was made to re-affirm the previous Board vote to appoint Gary Mitchell as part-time Police Officer. Kirchner and Wilton voted in favor. Skorput Cooper voted against appointment, maintaining that the Board should wait for an updated opinion from Town Counsel.

October 6, 2008

Open Meeting. Present: Tina Skorput Cooper, Chair; Curt Wilton. Michael Kirchner not present. Also present: Administrative Assistant Mark Webber.

Zoning Changes. Tina Skorput Cooper asked that the Planning Board include downtown zoning changes, including the Old Town Hall, when they conduct public hearings to consider a zoning change for properties on Albany Road across from Troy's Garage.

Halloween Activities. "Trick or Treat" will be on October 31 from 5:30 to 7:30 with a parade and party to follow at the Town Offices.

Road Work Bids. Following a review of road paving bids accepted at the 9-22-08 meeting, the Board awarded contracts to All States Asphalt (High Street reclamation project) and Palmer Paving (High Street and Swamp Road paving projects).

Library Deliveries. The Friends of the Library have asked that the fire lane leading from the parking lot to the Library side door entrance be paved so that the Bookmobile servicing the Library can unload there instead of the front entrance. Curt Wilton will get an estimate but warned that it would be expensive. Tina Skorput Cooper said she would prefer the fire lane not be expanded for safety reasons (the area is used by children and vehicles might be a problem).

Facility Use. Noting the condition of the bathrooms after practices and games, Peter Skorput asked that the youth soccer team coaches be advised to instruct players to take off their spikes before entering the building.

LAW PROPOSED BY INITIATIVE PETITION

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 6, 2008?

This proposed law would reduce the state personal income tax rate to 2.65% for all categories of taxable income for the tax year beginning on or after January 1, 2009, and would eliminate the tax for all tax years beginning on or after January 1, 2010. The personal income tax applies to income received or gain realized by individuals and married couples, by estates of deceased persons, by certain trustees and other fiduciaries, by persons who are partners in and receive income from partnerships, by corporate trusts, and by persons who receive income as shareholders of "S corporations" as defined under federal tax law. The proposed law would not affect the tax due on income or gain realized in a tax year beginning before January 1, 2009. The proposed law states that if any of its parts were declared invalid, the other parts would stay in effect.

A YES VOTE would reduce the state personal income tax rate to 2.65% for the tax year beginning on January 1, 2009, and would eliminate the tax for all tax years beginning on or after January 1, 2010.

A NO VOTE would make no change in state income tax laws.

LAW PROPOSED BY INITIATIVE PETITION

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 6, 2008?

This proposed law would replace the criminal penalties for possession of one ounce or less of marijuana with a new system of civil penalties, to be enforced by issuing citations, and would exclude information regarding this civil offense from the state's criminal record information system. Offenders age 18 or older would be subject to forfeiture of the marijuana plus a civil penalty of \$100. Offenders under the age of 18 would be subject to the same forfeiture and, if they complete a drug awareness program within one year of the offense, the same \$100 penalty. Offenders under 18 and their parents or legal guardian would be notified of the offense and the option for the offender to complete a drug awareness program developed by the state Department of Youth Services. Such programs would include ten hours of community service and at least four hours of instruction or group discussion concerning the use and abuse of marijuana and other drugs and emphasizing early detection and prevention of substance abuse. The penalty for offenders under 18 who fail to complete such a program within one year could be increased to as much as \$1,000, unless the offender showed an inability to pay, an inability to participate in such a program, or the unavailability of such a program. Such an offender's parents could also be held liable for the increased penalty. Failure by an offender under 17 to complete such a program could also be a basis for a delinquency proceeding. The proposed law would define possession of one ounce or less of marijuana as including possession of one ounce or less of tetrahydrocannibinol ("THC"), or having metabolized products of marijuana or THC in one's body. Under the proposed law, possessing an ounce or less of marijuana could not be grounds for state or local government entities imposing any other penalty, sanction, or disqualification, such as denying student financial aid, public housing, public financial assistance including unemployment benefits, the right to operate a motor vehicle, or the opportunity to serve as a foster or adoptive parent. The proposed law would allow local ordinances or bylaws that prohibit the public use of marijuana, and would not affect existing laws, practices, or policies concerning operating a motor vehicle or taking other actions while under the influence of marijuana, unlawful possession of prescription forms of marijuana, or selling, manufacturing, or trafficking in marijuana. The money received from the new civil penalties would go to the city or town where the offense occurred.

A YES VOTE would replace the criminal penalties for possession of one ounce or less of marijuana with a new system of civil penalties.

A NO VOTE would make no change in state criminal laws concerning possession of marijuana.





LAW PROPOSED BY INITIATIVE PETITION

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 6, 2008?

This proposed law would prohibit any dog racing or racing meeting in Massachusetts where any form of betting or wagering on the speed or ability of dogs occurs. The State Racing Commission would be prohibited from accepting or approving any application or request for racing dates for dog racing. Any person violating the proposed law could be required to pay a civil penalty of not less than \$20,000 to the Commission. The penalty would be used for the Commission's administrative purposes, subject to appropriation by the state Legislature. All existing parts of the chapter of the state's General Laws concerning dog and horse racing meetings would be interpreted as if they did not refer to dogs. These changes would take effect January 1, 2010. The proposed law states that if any of its parts were declared invalid, the other parts would stay in effect.

A YES VOTE would prohibit dog races on which betting or wagering occurs, effective January 1, 2010.

A NO VOTE would make no change in the laws governing dog racing.



Looking Back: Historical Reflections on West Stockbridge

State Line: One-Time Economic Powerhouse of Western Mass. By Seth Kershner

Now that the New York State Highway
Department has been working on the bridge
spanning I-90 for several months, it might seem fit
to take in the scene that one sees while waiting at
the new stoplight. After all, a westbound traveler has
to cross from Massachusetts into New York by going
through State Line. While there may seem to be
little of interest about the area today, in fact this
hamlet was once an economic powerhouse for far
Western Massachusetts.

The tiny town had an auspicious start when the first railroad into Western Massachusetts, the Hudson and Berkshire, blazed a trail in 1838 from Hudson, NY, to State Line. From there, the railroad made its way a further three miles, into West Stockbridge proper, stopping to dip into the deep ore beds along present-day Rte 102. According to Edna Bailey Garnett, the hauling of marble and iron ore formed "the stimuli and backbone of the enterprise."

Garnett's book on West Stockbridge has several photos of the stately State Line Station, which stood about 300 feet from the boundary line. Sheila Thunfors kindly talked with me about another building that may have served as a stagehouse during those

railroading years, an ancient two-story structure that remained standing up until only a few years ago. This stagecoach stop stood across the street from the former site of The Line, a funky saloon with a reputation for rowdiness. While The Line has since been split into commercial units, restored and now leased by Ivy Mountain Associates, its colorful past is partly what made State Line well-known as a place where there was always a cold drink awaiting the weary workingman.

The manufacture of grog also played a vital role in the area's economy. West Center resident and history buff Billy Kie tells me that John Losty's brewery was one of several State Line suds factories in operation in the early 1900s. A Chatham Courier article from 1984 even has it that Losty's second floor was "the scene of many an exciting cock fight of a Saturday evening."

The contents of many of Losty's hand-blown bottles were consumed not far from whence they came – just across the street, in fact, at a hotel and bar whose history will be the subject of a future column in the Local Yokel.■




Dam Review. The Board approved an agreement with Fuss & O'Neill, an engineering company from Springfield, to conduct a State-mandated structural engineering report on the Shaker Mill Dam. This report is in addition to the State-mandated Emergency Action Plan (EAP) for the dam.

Card Pond Weed Removal. Previous attempts to rid the Card Pond beach area of aquatic weeds having proven unsuccessful, the Board approved an application for Notice of Intent for chemical weed removal. Lycott Engineering will submit the notice to the Conservation Commission at the request of the Parks and Recreation Commission.

Planning Board. The Board reviewed a request from the Planning Board to place an article on the next Special Town Meeting for the purpose of paying the Planning Board Secretary for services during the prior fiscal year. The bill for services was not submitted until after the FY '08 books had been closed. The Board agreed, although no date has been set for a Special Town Meeting.

Executive Session. The Board voted to go into Executive Session for the purpose of discussing opinions from Town Counsel relative to MGL Chapter 39:23B (3) and not to return to open meeting session upon its completion.


Thank you to everyone who made our Craft Fair a success! Also, our Gift Wrap fundraiser was the most successful yet. What a wonderful way to begin our year.


