Residency information is used to assure that the outstanding educational and co-curricular opportunities offered by the district are provided only to Neptune residents. Residency information is investigated, and falsification of this data may result in law enforcement action and tuition charges.

The forms in this supplementary enrollment packet are required in unusual situations to prove that a child is eligible for a free public education in the Neptune School District. They must be submitted along with the *Student Enrollment and Residency Verification Form*.

If a child is living with a Neptune resident other than a parent or legal guardian, the following must be completed:

Affidavit A – Completed by the Neptune Resident

Affidavit B – Completed by the Non-Resident Parent or Guardian

Affidavit E – Completed by Landlord if the Neptune Resident is a Renter

If a family has recently moved into Neptune and is not yet able to submit documentary proof of residency as detailed on the Enrollment Form, the following must be completed:

Affidavit C – Completed by the Parent or Guardian

If a family has recently moved into Neptune and is living with family or friends, the following must be completed:

Affidavit D – Completed by the Homeowner

Affidavit E – Completed by Landlord if the Neptune Residence is Leased or Rented
