# **RULES AND REGULATIONS**

1. All vendors are required to complete and submit the High Hopes Holiday Market application form and provide the following. Please note that applications that are not completed with all required paperwork by **Friday**, **October 9**, **2015** will not be considered.

- a) Signed Hold Harmless Agreement
- b) Signed Rules and Regulations Agreement
- c) Certificate of Insurance with High Hopes named as Certificate Holder (Food Vendors Only)
- d) Completed Old Lyme Temporary Food Service Event Application (Food Vendors Only)
- 2. Vendor agrees to donate 15% of all sales made during the event to High Hopes Therapeutic Riding. Vendors choosing to become a vendor sponsor pay a one-time \$250 donation to High Hopes Therapeutic Riding and are guaranteed a highly visibly vendor booth. Please include payment with your application.
- 3. All registration forms must be received by Friday, October 9, 2015.
- 4. Please note that space is limited and all vendors will not be accommodated due to this. Applicants will be notified no later than Friday, October 16, 2015 of their status.
- 5. All vendors (excluding food trucks) will be provided a 10' x 10' numbered space in our indoor arena. Numbers will be assigned and emailed one week before the event.
- 6. All vendors must bring their own tables, chairs, volunteer help, etc.
- 7. Due to fire code, covered tents are **NOT** allowed inside the arena (wire framing is ok).
- 8. Banners are permitted provided they do not block surrounding vendors.
- 9. Market will be held rain or shine from 12 pm 4 pm November 15, 2015.
- The Marketplace will open for set-up at 9 am on the day of the event and vendors must have their area set-up before the Market opens at 12 pm.
- 11. Vendor space must be thoroughly cleaned and vacated within one hour after the close of the event (5:00 pm).
- **12.** Electrical access must be requested on the application and will be granted on a first come first serve basis. Only industrial extension cords may be used and must be safely operated according to fire code requirements. Please ensure cords are not in high traffic areas.
- 13. Vendor is responsible for bringing their own electrical cords and power strips.
- 14. Vendors must give 48hr. notice for cancellations failure to notify High Hopes will result in a \$250 fee.
- **15.** High Hopes has authority to exercise sole discretion and terminate a vendor for violation of any of the above Rules and Regulations.

#### Guidelines for Selling at the Market

- Vendors selling unprocessed, processed and/or prepared foods shall do so in compliance with the requirements of the Health Department, and Department of Agriculture and Markets. Products must be free of disease and insects or defects; products are to meet standards of quality, freshness, size, and grade.
- 2. Vendors must bring their own supplies for display and sale of products and must not be constructed in a manner that poses a hazard to the public or restricts easy access.
- **3.** Vendors are required to keep their space neat and clear of obstacles, litter, and debris and shall not block sight of surrounding vendors.
- 4. No form of discrimination is permitted at the market.
- 5. No unauthorized solicitation is permitted at the market.
- 6. Vendors must remain at the market for the entire market day until the closing time.
