2014 Annual AWMI Conference in Savannah, GA

Wow! I cannot say enough on how our 2014 Annual Conference was a true success. We had the opportunity to learn and network with so many outstanding women and even a few gentlemen from the metals industry.

I was fortunate, as were many others to participate in a Port of Savannah Tour on Thursday. Many of our attendees took the opportunity. I was amazed at the vast size of the operation and the coordination that takes place minute by minute to get freight in and out at the port. We were joined by Glenn Kidd and Scott Stewart for a summarized version of Platt's Training three-day training module in a half day on each carbon and aluminum. Thursday evening was the official start of our annual conference with Keynote Speaker, Dr. Leslie Joyce from Novelis. She did an outstanding job in engaging the audience and sharing experiences for each of us to learn from. The evening was capped off with a networking event sponsored by our Central Region. The event was designed to meet and get to know our executive board of directors as well as encourage each attendee to mingle with others in our industry.

I have to say I loved the way the schedule of events was designed. We began Friday morning with knowledge and wit of Economist, Dr. Chris Kuehl. Chris has a personality that kept you totally captivated while delivering some great economic information. The day charted on including a panel sharing their viewpoints on: "The Rise of New Technology in Manufacturing". Gabriela Felipe spoke on innovation initiatives her team at Gerdau has been executing. Henkel Corporation's, Dr. William Fristad educated the group on the progress of metal pretreatment technologies and new surface coatings to metals. The third panelist was Scott Condreav from Sapa Extrusions North America. Scott shared his thoughts on the importance of including aluminum extrusions for lengthening the life cycle of many parts while making them at a reduced weight and potentially more durable.

Áfter breaking for the association business lunch, the afternoon session began with Director of Member Relations from Catalyst Katy Breitenbach. Katy reflected on how Catalyst, a nonprofit organization, collaborates with their member companies to advance the number of women in the global labor force and into management positions. AWMI member, Jodi Parnell, VP of Supply Chain Management of O'Neal Steel offered her story on entering the metals industry and the evolution in supply chain management she has experienced throughout her career. We concluded our day with well-known author of Gender Talk Works, Connie Glaser, as she enlightened the audience with her expert examples on women's leadership and the true differences in women and men. She taught us to avoid the use of some communication styles and to make others more advantageous for success in the business world. We were included in activities on how some opening lines that may work for men would create more discredit to women in the same work environment.

The 2014 AWMI Conference came to a close on November 15th with each of our 21 chapters assembling for their bi-annual Regional meetings followed by the International Board of Directors meeting.

Our four cornerstones of Educate, Grow, Mentor and Network were all presented professionally while keeping you wanting to hear more from the next speaker. I look forward next year's conference, Nov. 12-14, in Tucson, Arizona. I would love to see you there.

Clara Bal - Amstek Metal AWMI Chicago Chapter Past President


