
President's Message

The Richard F. Doyle Award is a national award that is presented annually to the officer who has made the most significant contribution to the Federal Probation and Pretrial Services System or the broader field of corrections. This award commemorates and perpetuates the ideals of Richard F. Doyle, an outstanding officer and the first president of the Federal Probation and Pretrial Officers Association.

The winner of the 2011 Richard F. Doyle award is United States Probation Officer Thomas Plumley from the Southern District of Georgia. He was presented the award by FPPOA President Barbara Oswald in a local ceremony in Savannah, Georgia. Presiding over the event was Chief U.S. District Judge Lisa Godbey Wood and U.S. District Judge William T. Moore, Jr. The presentation was held in the ceremonial courtroom of the Tomochichi

USPO THOMAS PLUMLEY WINS SOUTHEAST REGION LINE OFFICER OF THE YEAR AWARD

Formality and tradition were strong on November 8, 2011, in Savannah, Georgia. On this date, I had the pleasure of attending the awards ceremony to honor the 2011 Southeast Line Officer of the Year. Because I was in the South and the South being so well known for its charming demeanor, this special occasion was held in nothing less than the ceremonial courtroom with not one but two District Court judges presiding. After the formal calling of the Court to order and kind words from the Court regarding the occasion, it was time to make the presentation. It was

with great pride that I presented the 2011 Southeastern Ezra Nash Line Officer of the Year award to USPO Thomas Plumley. Thomas is a veteran officer in the supervision unit in the Southern District of Georgia.

Thomas began his service with the agency when he was hired as a student contractor in 1991. He worked in the Augusta, Georgia, office while completing his undergraduate degree. Upon obtaining his MBA from Brenau University in 1995, he was hired by the U.S. Pretrial Services Office in the Eastern District of Virginia. He returned to the Southern District of Georgia in June 1997 and began working in the post conviction supervision unit in the Savannah office. Thomas' caseload includes sex offenders and special needs offenders.

Specialist Thomas works in the supervision unit and maintains an offender caseload of approximately 50 people. Her office is located in the local Residential Re-entry Center (RRC) in Leavenworth, Kansas, which houses federal

offenders from both the District of Kansas and the Western District of Missouri. Because of this, Ms. Thomas' role is one of liaison between the Probation Office, the RRC staff, and the residents. She is involved on a regular basis with the New Resident Orientation program (an introduction to the halfway house), the New Offender Orientation program (an introduction to federal supervision), and weekly staffings.


Specialist Thomas has also played an integral part in the BOP Project, a program developed by officers and re-entry staff from both Kansas and the Western District of Missouri, who have completed the DOWD certification. In the BOP project, Specialist Thomas and other re-entry personnel meet with inmates prior to their release, to assist them in preparing for transition to the community and the work force. Further, Specialist Thomas plays an active role in the district's JobTrac program, assisting offenders with weekly job searches and community resources

The nomination reads, "Thomas is very dedicated to assisting federal offenders and their transition to the community. She is an excellent example of a fine officer who has taken the re-entry initiative to another level by becoming involved with the offenders long before they enter the RRC. Through her skills, dedication, and passion for the work, Kristine Thomas has demonstrated that she deserves to be considered for the Regional Line Officer Award."



USPO LAURA TAIT WINS NORTHEAST REGION LINE OFFICER OF THE YEAR AWARD

The Northeast Region would like to announce that U.S. Probation Officer Laura A. Tait of the District of Maine was selected as the 2011 Charles L. Chute Regional Line Officer of the Year for the Federal Probation and Pretrial Services Officers Association. She was selected from a group of several worthy applicants.

Laura was hired as a U.S. Probation Officer in the Eastern District of New York in December 2000 and was initially assigned to the presentence unit. She transferred to the field supervision unit in 2002, and received some of that district's highest performance evaluation She consistently exceeded performance measures relative to training and field hours, and was involved in the search team and the Tri-District CISM Team. Laura holds a Bachelor of Science Degree in Criminal Justice, a Master of Art Degree in Criminal Justice and Criminology, and was also a Credentialed Alcoholism and Substance Abuse Counselor (CASAC) in New York State. In December 2007, Officer Tait was hired in the District of Maine.



In her first year in Maine, Laura researched, designed and implemented an Offender Re-Entry program which was approved by the District Judges. Because of this program, Laura was nominated and selected by her peers for the District's Special Contribution Award in 2008. In 2008, Laura was promoted to Re-Entry Program Specialist.

In 2009, Laura expanded the Re-Entry Program to include other officers and outside agencies, including the RRC, the local careers center, local employers, and a local civic group. Laura also developed and implemented an Employment Readiness Program to improve the employment statistics of the district. Also in 2009, Laura became certified in TruThought, a cognitive behavioral treatment program which had been previously implemented in the District of Maine, but had languished.

In 2010, Laura began the arduous process of certification as an Offender Workforce Development Specialist (OWDS), and completed the significant work required to obtain this certification in the fall of 2010. She brought back ideas and has continued to expand the Offender Workforce program, and has also mentored an administrative assistant to help with the program. Also in 2010, Laura began researching the effectiveness with re-entry and workforce programming, including using an intern to assist in this endeavor.

In 2011, Laura coordinated the district-wide training for officers and the RRC staff on The Change Company interactive journals. She initiated the first orientation group, as well as the first Social Networks group, utilizing the journals. Laura continues to lead by example and to assist other officers in moving their supervision activities toward more evidence-based programs. Officer Tait's efforts have significantly furthered the organizational objectives of the District of Maine and she continues to exemplify the district's vision "We Strive to Change Lives!" As evidence of this, her peers nominated and selected her for the 2011 Mission and Vision Award.

USPO JENNIFER KELLY WINS GREAT LAKES REGION LINE OFFICER OF THE YEAR AWARD

Jennifer Kelly has been a United States Probation Officer in the Northern District of Illinois since 2001. She spent the first four years in the presentence division and has been in the supervision division since 2005. Jennifer was one of four officers involved in spearheading a grassroots workforce development program in the Northern District of Illinois in 2006. Since that time, she has been very instrumental in the development of the district's workforce development program.

In January 2007, Jennifer became a certified "Makin' It Work" trainer. Upon her return from the week long training program, she developed a job readiness program and curriculum which evolved from a one day to a four day training program for offenders.

Since the inception of the program, Jennifer has been the backbone of the "Making it Work" program. Although most of the officer's who piloted the program have since moved on, Jennifer continues to be the integral piece to this ever-changing program that continues to evolve for the betterment of the offenders. Jennifer is the leader of this program and through her passion, she has inspired other officers to volunteer their time and efforts to become a part of this team. Their goal is to teach the cognitive model and how to incorporate it into, not only employment situations, but also in everyday life situations.

As a result of her extensive experience with the "Making-it-Work" program, it has also inspired her to become an adjunct professor at Roosevelt University. This allows her to educate individuals on the United States Probation Officer's role and the importance of supervised release and probation. In that same vein, Jennifer was also inspired to become a STARR coach to learn new techniques to reduce recidivism, and to incorporate STARR into the "Making it Work" program. This will not only enhance the existing program, but better assist the trainers in changing the offender's criminal thinking for long lasting positive changes.

The job readiness program in the Northern District of Illinois has been a model for other districts who have heard about the curriculum Jennifer created. In fact, several officers from Wisconsin visited our office to observe the four day program. Jennifer's vision for an in house job readiness program has exceeded all expectations. Her enthusiasm and passion have carried the program this far. She went above and beyond her normal line officer duties despite supervising a normal caseload size.

The thing that is most impressive is that Jennifer has remained passionate about workforce development over the years and continues to look for creative ways to positively impact offender's lives.

USPO BRENT FLOCK WINS WESTERN REGION LINE OFFICER OF THE YEAR AWARD

The FPPOA is proud to announce that U.S. Probation Officer Brent Flock of the District of Idaho as the 2011 Western Region Line Officer of the Year. Officer Flock has been an officer since 2001 and has been a full-time presentence writer. Beginning in 2005, he volunteered to supervise the caseload on the Duck Valley Indian Reservation which is shared by the Districts of Idaho and Nevada, all while maintaining his presentence caseload.

Officer Flock is instrumental in his district with training new officers, law clerks, prosecution staff and local defense attorneys regarding guidelines calculations, interviewing defendants and disclosure of confidential information. He began testing Microsoft Word in 2009, which helped facilitate the District's move to PACTS PSX.

When Chief Jeffrey Thomason came to the District of Idaho in October 2010, he immediately noticed the respect Officer Flock had earned from colleagues, supervisors, the Court, the U.S. Attorney's Office and the criminal defense bar. Upon request from the Federal Public Defender, Officer Flock developed a policy that expedited the procedure for sentencing illegal aliens charged with re-entry crimes. He also recently undertook the process of developing a Mission and Vision statement for the District. On top of all these duties and assignments, Officer Flock enrolled in a Master's in Business Administration program in 2010.

It is probably best summed up by Chief Thomason, "Whether he chooses to focus on supervision, investigations, or long-range strategic planning, Officer Flock provides an excellent service to the court, community, and the probation office."

ADVERSE ACTION POLICIES AND PROCEDURES: WHAT YOU SHOULD KNOW

United States Probation and Pretrial Officers (USPOs) are cognizant of the rights of defendants, procedures of the court, and local rules and policies guiding their positions, but are we aware of our own rights and where we fit into the federal workforce?

The position of the USPO is a civil service position that is classified as excepted, non-preferential service, and is not a Title V agency by definition. USPO's are the only cadre of Federal Law Enforcement officers in the Federal Judiciary. The national element is the Administrative Office of the United States Courts (AOUSC), but primary control is left to individual districts. So, what does this mean?

This means that USPOs are not subject to the laws of the Executive Branch, not protected by the Civil Service Improvement Act and not subject to the statutory and regulatory provisions governing adverse actions. The administrative policies and procedures are guided by the Administrative Office's Guide to Judiciary Policy. Although USPOs are covered by various provisions of the Civil Service Reform Act (CSRA), CSRA does not provide any administrative or judicial review to judicial branch employees. Although USPOs fall under the District Courts as noted in the Code of Federal Regulations, USPOs are not mentioned in the code with respect to adverse action statutes.

According to the Guide to Judiciary Policy, judiciary employees have been held to have no property interest in their employment and thus have no due process protection under the Constitution (Vol 12, Ch 3c). The Sentencing Reform Act created a limited exception to the general lack of procedural employment protections for removals and/or terminations of USPOs appointed to serve with compensation, who may

be removed by the district court only for cause (Vol 12 Ch 3f), which provides some form of due process for USPOs. JCUS-MAR 93 pg 17 states, while there is no requirement that procedures be established in order to remove a probation officer, the for cause phrase suggests that a probation officer is entitled to notice and an opportunity to be heard before being discharged. Unless the court has voluntarily adopted an adverse action plan, adverse actions for court employees do not have to adhere to any particular procedure (with the exception of removal).

The Guide to Judiciary Policy referenced performance standards, but there are no identified critical elements of the position of USPO or any structure for local management plans. Procedures to "review" certain components of performance management are not required according the Performance Management Guideline (JCUS-Sep 08 p 25).

In recent times, the phrase Reduction in Force (RIF) has been used as an alternative for budgetary constraints. The Guide to Judiciary Policy has no guidelines for a reduction in force. The office of Personnel Management guidelines that require that tenure, Veteran's preference, length of service, and performance be considered do not apply to USPOs.

The Employment Dispute Resolution Plan was developed and implemented to address the lack of protection with regard to discrimination. This seems to be one of the few national policies that provides protections to USPOs. The statutes and regulations developed by various Congressional Bills and the various protections of the executive branch employees performing similar law enforcement duties do not currently apply to USPOs; thus, USPOs are performing similar job functions without similar protections.
