CONSEQUENTLY, I UNDERSTAND THAT BOTH PARTIES ARE ABSOLVED FROM ANY ADDITIONAL DEMANDS ARISING DURING THE COURSE OF APPROVED USAGE, INCLUDING BUT NOT LIMITED TO CLAIMS TO PRIVACY, PUBLICITY, AND LIBEL.
