Rental Application Process

Application Submission

- Application must be completed in its entirety and signed
- Please provide a copy of your driver license and your most recent paystub with this application
- All Applications fees must be paid-in-full at time of application submission. Credit cards are accepted for on-line applications only. For applications submitted at our office, please pay with cash, money order, or cashier's check payable to Shucom Properties. Application Fee: \$25.00

Upon receipt of completed application and applicable fees, your application will be processed. Applications remain in processing until the following requirements are completed: income verification, current and/or past landlord reference, credit check and background check. The application process typically takes 3-4 business days to complete. You will then be notified of your application approval and the amount of your security deposit. Please take note of the following rental criteria:

- Shucom Properties, Inc. operates pet-free communities. Dogs and cats are not allowed on the property at any time.
- Applicants must have gross income of at least 3 times the rental amount.
- Applicant must be employed at least 3 months with current employer.
- You will be denied rental if you misrepresent any information on the application. If misrepresentations are found after a rental agreement is signed, your rental agreement will be terminated.
- You will be denied rental if in the last 5 years you have an arrest for any type of crime that would be considered a threat to rental property or the ability of other residents to peaceful enjoyment of the premises.

Security Deposit

The amount of your security deposit will depend on your credit and rental history. A minimum deposit of \$199 is established for applicants with acceptable credit and who have recently completed a verifiable lease.

Signing a Lease

Once your application has been approved, you will have 30 days to come into our office, sign your lease, and reserve your apartment. You must pay at least half of your deposit when you sign the lease.

Move-In

We will schedule a move-in date and time when you will be given the keys to your apartment and a movein inspection will be performed. Before moving in, you are required to have appropriate utilities activated, and pay any balances of security deposit and first month's rent.
