

OUR WORKSHOP

This presentation will enhance your skills with children, adolescents, and adults and increase your practical knowledge of how to apply art therapy, play therapy, neurobiology-focused, and mind-body approaches to trauma intervention. In particular, it will introduce you to trauma-informed expressive arts therapy, why it is a "brain-wise" approach to treatment and how to apply practical strategies to your work with children and adults who have experienced a wide variety of traumatic events and other challenges. The focus of the presentation is to introduce the participant to expressive arts activities designed specifically for children, adults and families who have experienced traumatic events or loss, with an emphasis on traumainformed practice, resilience, self-regulation, positive attachment and "thriverhood."

- Identify two expressive arts interventions to enhance resilience and posttraumatic growth;
- Define three major components of the expressive therapies continuum and how they apply to trauma intervention.

She has published numerous books (Creative Interventions with Traumatized Children, The Art Therapy Sourcebook, Understanding Children's Drawings, Handbook of Art Therapy, among others), articles, and chapters, and has given more than 350 presentations on art therapy. Dr. Malchiodi is on the adjunct faculty of several universities and is a visiting professor to universities in the United States and internationally. She is also founder of the Trauma-Informed Practices and Expressive Arts Therapy Institute and has worked with a wide variety of community, national, and international agencies, particularly on the use of art therapy for trauma intervention, disaster relief, mental health, and wellness. The President of Art Therapy Without Borders, a nonprofit organization supporting international art therapy initiatives and service, Dr. Malchiodi is the first person to have received all three of the American Art Therapy Association's highest honors: Distinguished Service Award, Clinician Award, and Honorary Life Member Award. She has also received honors from the Kennedy Center and Very Special Arts in Washington, DC.
