This one day conference is an opportunity to take a critical look at the current state of 'user involvement'. Our plenary speakers are: Dr. Rachel Hurst, Director of Disability Awareness in Action; Professor Nick Crossley, University of Manchester; Dr. Lorna Warren, University of Sheffield, and member of the Older Women's Lives and Voices project; Dr. Val Williamson, Norah Fry Research Centre, and a co-researcher.

#### We invite contributions on the following themes:

**Margins to mainstream -** With its beginnings in radical activism, service user involvement has become a mainstream activity in many different settings. What are the consequences of this 'acceptance' and what may this mean for all involved?

**Motivations and expectations -** Should people always have to get involved? For those choosing to be involved, what are their reasons? What is involvement intended to achieve? And are expectations met?

**Nothing about us without us -** In the 21<sup>st</sup> Century is service user involvement able to challenge the status quo, resist oppression, and stand-up for social justice?

**Impact and outcomes -** Has service user involvement made a difference to services, research, how professionals practice, and to service users' lives?

**Agents of knowledge -** The expression 'agents of knowledge' is one used to suggest the possession of a knowledge that originates through living an experience or experiences. It is a knowledge that has originated from direct experience. Has such a knowledge influenced or challenged conventional 'expert' knowledges?

#### Selecting workshop contributions:

The criteria for selection will include: relevance to the conference theme; relevance to delegates from a wide variety of backgrounds; originality; quality of presentation of workshop proposal; contribution to a balanced programme; potential for a stimulating discussion.

- 2. Brief outline of your background and interest in this theme.
- 3. Summary of workshop presentation.
- 4. List of up to five points for discussion.
