The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s):

Count: 1 Threats of Violence-Reckless Disregard Terror
In Violation of: 609.713 subd. 1
Penalty Statute: 609.713 subd. 1 - Terroristic Threats-Reckless Disregard Risk
MOC: A9111
ICR: 15061068
Penalty: 5 years or \$10,000 fine or both (MSG SL 4)

On or about December 4, 2015, within the County of Olmsted, Adam Lawrence Bussman did wrongfully, unlawfully and feloniously directly or indirectly threaten to commit a crime of violence with the purpose of terrorizing another, to-wit: BLN, or in reckless disregard of the risk causing such terror.

Count: 2 Threats of Violence-Display Replica of Firearm
In Violation of: 609.713 subd. 3(a)(2)
Penalty Statute: 609.713 subd. 3(a)(2) - Terroristic Threats-Reckless Disregard Risk

Penalty: 1 year and 1 day or \$3,000 fine or both

On or about December 4, 2015, within the County of Olmsted, Adam Lawrence Bussman did wrongfully, unlawfully and intentionally display, exhibit, brandish, or otherwise employ a replica firearm or a BB gun in a threatening manner and acted in reckless disregard of the risk of causing terror in another person.

Count: 3 Drugs-5th Degree-Possess Schedule 1, 2, 3, 4-Not Small Amount Marijuana
In Violation of: 152.025 subd. 2(a)(1)
Penalty Statute: 152.025 subd. 2(a) - Drugs - 5th Degree - Possession - Penalty

Penalty: 5 years, \$10,000 fine, or both (MSG SL 2)

On or about December 4, 2015, within the County of Olmsted, Adam Lawrence Bussman did wrongfully, unlawfully and feloniously possess one or more mixtures containing a controlled substance classified in Schedule I, II, III, or IV, to-wit: methamphetamine.

STATEMENT OF PROBABLE CAUSE

Your complainant is a licensed peace officer employed by the Rochester Police Department. In that capacity your Complainant has reviewed the police reports relating to Adam Lawrence Bussman, the above-named defendant, and the allegations contained therein. Based upon that information, your complainant believes the following to be true and correct.

On December 4, 2015, Rochester Police Officer R. Lodermeier #2402 was dispatched to the Mayo Clinic where he met with Security Specialist David Moitzhheim. Moitzheim stated that security was made aware of threatening Facebook postings by a patient named Andrew Lawrence Bussman (the defendant). The posts were time stamped on December 3, 2015 at 10:42 a.m. The first posting shows the defendant holding what appears to be an assault style weapon at "port arms." The weapon had an orange tip on the muzzle of the barrel, and may be a replica. The caption on that posting stated: "Touch it again, I f*ckin dare you. Not fond of the fill-in therapist." The second posting was a photo of the defendant's appointment schedule at the Mayo Clinic Gonda building. The appointment identifies the therapist (referred to herein as BLN). The caption of the posting states: "Intern hunting I go..."

The defendant was located at his place of employment in Rochester and placed under arrest. A small plastic baggie with a glass-like substance was found in the defendant's front right dime pocket of his jeans. The substance tested positive for methamphetamine.

The defendant stated that he is being seen at the Mayo Clinic for a hand injury. He had a therapy appointment on December 3, 2015. The defendant admitted that he made the two Facebook postings within an hour of his last hand therapy appointment. The first post with the gun was made out of frustration because the medical staff manipulated his hand during the therapy and it hurt. The defendant admitted that the substance in his pocket was methamphetamine and that it was his. The defendant admitted trying methamphetamine a few times within the last month.

Complainant requests that Defendant, subject to bail or conditions of release, be:

- (1) Arrested or other lawful steps be taken to obtain Defendant's appearance in court; or
- (2) Detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
