Federal verification requires that we confirm your income via one of the two processes noted below.

IRS DATA RETRIEVAL PROCESS or TAX TRANSCRIPT - You are required to submit your Parent's 2011 IRS tax information using either the FAFSA IRS Data Retrieval Process or by requesting a 2011 tax transcript from the IRS.

1. IRS DATA RETRIEVAL PROCESS:

To use the IRS Data Retrieval Process (the recommended method if you are allowed to do so):

If you file electronically, approximately 3 weeks after filing by log on to the FAFSA Web site at www.fafsa.gov and select Make FAFSA Corrections link.

Change your tax information from “will file” to “have filed”. A series of questions will appear and if you are able, the IRS Data Retrieval Option will be made available.

Follow the instructions to have the IRS data uploaded to your FAFSA record.

Complete the FAFSA update. **Make sure Cal Poly is still listed as a school to receive the FAFSA record.**

Cal Poly will then receive record of the updated FAFSA with the IRS confirmed income data.

2. TAX TRANSCRIPT:

If you cannot use the IRS Data Retrieval on the FAFSA, tax transcripts can be requested on the IRS Web site at www.irs.gov or by calling the IRS at 1-800-908-9946. Make sure you keep your original and provide a COPY to our office. We will not be able to make copies for you.

Per NEW federal regulations, the only acceptable documentation is the IRS Data Retrieval Process or federal tax transcript. No State Tax Returns are required or accepted.

Include student’s Cal Poly EMPL ID on all documents.
