19 distressing that you're having a meeting
20 and it appears everybody's more in a hurry

9 I was able to review 'em. And I have the
10 following comments.

11 I'd like the study to include the
12 rail line to go beyond the 30 mile
13 corridor that's ending in Suffern, to take
14 into account Stewart Airport.

15 I'd like to see -- go on record as
16 saying I'd like to see the Bridge replaced
17 and either a larger superstructure put
18 into place or two bridges put in its
19 place, and I'd like to see a rail line
20 that extends to Stewart Airport attached
21 to that, for travel and connection into
22 the east side of the River.
