**INSTRUCTIONS:** All FFL transfers are assessed a \$5 background check fee in addition to the transfer fee. All fields on this form must be filled out unless otherwise specified. Incomplete forms will delay processing. An e-mail address for the sender is required so we can send a copy of our FFL to them. Please allow for up to 24 hours after Nexus receives the gun to properly process it in our system (if you come in prior to this, your gun may not be available for pick up). Guns can only be released after the mandatory 5 business day waiting period which starts on the day after the date specified on the seller's invoice (does not include weekends or holidays) or the same day with a valid CWP.
